745-00	Road Materials and Supplies	Quarry Products, asphaltic products, concrete, and tools for road work (non-heavy equipment). This is for products only, use 913-00 if a contractor is used.
345-00	Safety Supplies	Face masks, gloves, ear plugs. Use 345-32 for first aid kits.
989-00	Sampling and Testing Services	For soil, water, or air.
990-05	Security Alarm Monitoring	Fire alarms, burglar alarms, video monitoring.
725-54	Security Equipment (includes installation)	Security cameras, gates, keypad door locks. Use 990-05 for security system monitoring.
990-67	Security Guard (Patrol) Services	
968-00	Sewer Maintenance and Repair Services	Includes septic work.
962-86	Shipping and Freight Services	Carrier Shipping, such as FedEx and UPS.
801-00	Signs: Equipment, Materials, and Supplies

988-88	Tree work	Tree trimming, tree removal, stump removal, arborists.

890-44	Water Meters: Equipment, Parts, and Supplies	Includes meter reading equipment.
890-00	Water Supply, Sewage Treatment: Equipment, Parts, and Supplies	Equipment for filtration, desludging, mixing, agitation, sewer inspections. Use 885-00 for chemicals.
578-00	Miscellaneous Products (Not Otherwise Classified)	Event supplies, flags, decorations, refuse containers, theatrical supplies.
961-00	Miscellaneous Services (Not Otherwise Classified)	Aerial photography, blueprint services, bus services, document shredding, mapping services, utility locator services, veterinary services, recycling services, web page design.
963-00	Non-biddable items	Fees, intergovernmental contracts, dues, postage, travel, meals.
