Participant assumes all risks relating to participating in the above program(s), including the risk of injury, property damage, or death. Participant hereby agrees to indemnify, defend, release and hold harmless the indemnified parties from any and all claims or liability (including attorneys' fees and defense costs) for bodily injury or property damage arising from his/her negligence or willful misconduct relating to participation in the above program(s). Participant's duty to release, hold harmless, indemnify and defend the indemnified parties shall not apply only when (1) the injury to person or property arises solely from the negligence or willful misconduct of the City or its agents or employees or volunteers; and (2) Participant has contributed in no part to the bodily injury or property damage. Participant hereby gives the City of Santa Cruz Police Department the right to use photographs taken of him/her while participating in the above activities for reproduction in any medium for purposes of advertising, trade, display, exhibition, or editorial use.
