SUBJECT: Arts Commission Focus on SculpTour

RECOMMENDATION: Motion to form a City Arts Ad Hoc SculpTour Program Committee

Background:

The City Arts SculpTour was initially created in 2009 to create an opportunity for sculptors to showcase their works to promote sales and to beautify downtown by locating sculptures in Cityowned and maintained landscaping beds. There are currently five beds that host the rotating collection of works. The original plan was for the sculptures to be on display for two years with approximately half of the sculptures changing each year. The artists were to receive an honorarium payment for displaying their work.

There was a discussion about the program at the January 2019 Arts Commission meeting. It was noted that rotating the works every year had proven difficult. For work that was already created, the honorarium was \$1,500 and the length of display is up to two years. It was presented that there were not many local sculptors who made the work to the scale and durability desired for outdoor display. Those that do make this kind of work – both locally and regionally – desired larger honoraria to make it worth their time and effort to apply for the program. Between 2009 and 2014, honoraria for works on loan ranged from \$750 to \$2,000. Since 2016, the honorarium amount was raised to \$10,000 for site-specific unique commissions with a four-year display period. Typically the provided honorarium covered installation costs. The length of display period and installation fees were negotiable depending on the specific project. For example, if a work required new footings the installation expense may be higher and the artist may negotiate having these costs covered in addition to the honorarium. The actual focus of that discussion was to advise staff on the interest of the Commission in commissioning artists for future SculpTour rotations.

Discussion:

Since the time of the last Arts Commission focus on the SculpTour program, there have been no rotation of sculptures nor any additional commissions for the SculpTour program. The art pieces on display are past due for rotation and some of them are not in good condition. Commissioner Patterson has stepped forward to volunteer to lead and Ad Hoc Committee to review the SculpTour program and recommend parameters for its operation at a future time to the full Commission.

An Ad Hoc Committee may only have three Commissioners and have an anticipated operating time of no more than six months. It is estimated that this Committee may meet an average of once a month, for no more than two hours at a time.

Fiscal Impact: None.
