**Approval of Minutes** – May 20, 2009

ACTION: Commissioner Gibson moved and Commissioner Steen seconded APPROVAL the minutes of May 20, 2009. The motion passed on a 5-0-2 vote; Commissioner(s) Subocz, Carter, Shultes, Steen and Gibson voting YES. Commissioner(s) Eriksen and Meyer absent.

## **Public Hearings –**

1. 229 Union St. 09-068 APN 005-032-06

Historic Alteration Permit to construct new foundation and raise building to convert lower floor-basement into habitable first-floor area, and install solar panels on rear elevation of a single-story dwelling on a substandard lot in an RL/H zoning district and located within the Mission Hill Historic District. (Environmental Determination: Categorical Exemption) (M. Bethke, owner/filed: 5/4/09)

Recommendation: Approval with conditions.

ACTION: R. Gibson moved and C. Shultes seconded approval of the Historic Alteration Permit for 229 Union Street, subject to the conditions attached as Exhibit "A", with the following changes: lowering the belly band to sit on top of the basement window heads and include a bullnose trim feature into the bellyband; expose 10-12 inches of the foundation wall at the base of the residence; remove the water table belly band; provide true divided lites and

mullions on windows and doors; enclose the area under the front entry stair and porch with horizontal siding to match existing siding on the house; applicant may increase the size of the first floor windows on the front elevation with either single-pane or double-hung windows. The motion passed on a 5-0-2 vote; with Commissioner(s) Shultes, Gibson, Carter, Subocz and Steen voting YES; Commissioner(s) Eriksen and Meyer absent.

## 2. City Budget Effects on Commission

Recommendation: Receive report from Planning Director.

Action: Acknowledged report from Planning Director J. Rebagliati who noted that Commission meetings would only occur for public hearing projects due to the economic hardship that currently faces the City; and that a four-day, nine-hour work day week would be implemented beginning June 29<sup>th</sup>, with flexibility for certain inspections that need to occur. She further noted that Volume III of the Historic Survey, related historic zoning incentives and a potential Mills Act program would be the only other historic programs which will be pursued during fiscal year 2009/2010, as time allows.

### 3. Mills Act Draft Program & Historic Preservation Zoning Incentives

Recommendation: Discuss draft program and potential zoning incentives.

Action: Continue exploration of the Mills Act to determine the experience of other jurisdictions and provide an information package to take to the City Council. Discussed the following potential historic zoning incentives: density bonus for larger scale development projects; allowing larger ADUs on historic sites; allowing additional variation to various zoning requirements (parking, setbacks, floor area ratios, etc.) for historic building sites. Commissioner Subocz will meet with D. Lauritson prior to the next Commission to discuss other potential incentives.

Recommendation: Discuss potential projects and budget.

Action: Discussed draft project list, lack of budget and continued item to next meeting.
