3. City of Santa Cruz/Soquel Creek Water District Desalination Task Force – Draft Operational Plan & Agreement materials July 2009

Director Kocher reported that Councilmember Rotkin brought the Water Commission concerns to the Desalination Task Force at its July 15, 2009 meeting. The Task Force will be addressing those concerns at a future meeting.

4. Ordinance No. 2009-14 Water Shortage Ordinance

The commission requested that staff provide information at the November meeting on the benefits of having an Ordinance that is codified and a clarification on Section 16. Effective Date whether the Ordinance expires on October 31.

#### **General Business**

1. Surface Water Treatment Rules – Long Term 2 (Oral Report)

Deputy Director/Operations Manager Tompkins reported on the work being done to meet the 2012 Surface Water Treatment Rules - Long Term 2. The Water Quality and System Improvement Study has been an ongoing project since 2002 and the item of most concern is disinfection by-products. The Basis of Design Report is going through an independent technical review and is expected to be complete in the spring. The review will look at the original work in order to determine if any changes that occurred during the course of the study may make other non-selected alternatives more feasible.

ACTION TAKEN: The Commission requested that a presentation of the findings be made at a future meeting.

2. Status Report on Stage 2 Water Restrictions (Oral Report)

Water Conservation Manager Goddard reported that we are about two-thirds of the way through the restriction period and water usage is lower than projected. The mandatory restrictions have had a big impact on customer usage. Two temporary staff have been hired and are dedicated to enforcement. The Conservation Office workload has been consumed by the restrictions, particularly in light of the mandatory 10% work furlough. Major customers such as the University, City Parks, City Schools, golf courses and cemeteries have made substantial efforts to reduce water usage.
