Minutes approved as submitted at January 6, 2010 meeting

## **Announcements - No action may be taken**

Announcements by Chair: Chair Zook stated that that she recommends reading the articles in the Santa Cruz Weekly regarding heroin use.

Other Commission Member Announcements: Commissioner Campbell announced that he will be resigning after this meeting. Commissioners and Councilmember Robinson, who was in attendance, expressed their appreciation for his time and energy for the past four years. Staff Announcements: CPVAW Coordinator Agnone introduced Lt. Mark Sanders who will be replacing Lt. R. Escalante as the SCPD Liaison to the Commission. Lt. Sanders provided some background of his time with SCPD. Coordinator Agnone provided a verbal report to Commissioners that included information on the safety skills/self-defense classes at the schools, Leonie Sherman's Community Hero award, Palo Alto Medical Foundation's distribution of brochure displays, and the possibility of two new interns in 2010. She also requested items for the January 6, 2010 meeting to be submitted no later than December 28. She reminded Commissioners that the City will go into an extended furlough from December 18 through January 4. She distributed a handout that provided data from the sexual assault quarterly reports and reviewed that information with Commissioners.

# **Approval of Minutes**

Minutes of November 4, 2009 meeting (note: no meeting in October)

Recommendation --- Approve, by motion, the minutes from the monthly meeting of November 4, 2009 as submitted. Commissioner Tobisch moved, seconded by Commissioner Christie, to approve the November 4, 2009 minutes as submitted. The motion passed unanimously (Commissioner Campbell abstained due to absence at that meeting).

#### **General Business**

- 1. Community Rally to Take Back the Night and Stop Violence Against Women
  Recommendation --- Hear request from community members to schedule rally to take back the
  night and stop violence against women and take action as needed.
  Coordinator Agnone with Commissioners Zook and Christie provided information from
  November 16 meeting of the ad hoc committee regarding this event. Due to a variety of
  scheduling issues, the event is tentatively scheduled for January. Commissioners were
  requested to provide feedback that would assist at the next meeting. The possibilities of
  partnering on a April or May Take Back the Night event with Take Back Santa Cruz group,
  organizing a Facebook page, including stakeholders, and other ideas were shared and
  committee members will meet to determine next steps with community members. Chair
  Zook is unable to attend the ad hoc meetings and Commissioner Polanco will replace her on
  the ad hoc committee.
- 2. Engaging the Bystander Workshops
  - Recommendation --- That CPVAW hear information from Engaging the Bystander ad hoc committee and take action as necessary. Commissioner Tobisch provided information to Commissioners regarding the project. Although there was a meeting scheduled on November 23, there are no recommendations for Commission action at this point in time.
- 3. <u>Stakeholder Round Table Discussion for Sexual Assault and Domestic Violence Service</u> Providers

Recommendation --- That CPVAW table this ad hoc committee.

ACTION: Commissioner Campbell moved, seconded by Commissioner Tobisch, that the Stakeholder Round Table ad hoc committee be sunset. The motion passed unanimously
