Approval of Minutes — November 5, 2009 and November 19, 2009

<u>ACTION:</u> Commissioner Foster moved, and Commissioner Tustin seconded, that the Planning Commission APPROVE the minutes of November 5, 2009 as submitted. The motion passed 6-0-1, Commissioners Quartararo, Daly, Foster, Schultz, Tustin and Warner in favor and Commissioner Kasparowitz abstaining.

<u>ACTION:</u> Commissioner Warner moved, and Commissioner Schultz seconded, that the Planning Commission APPROVE the minutes of November 19, 2009 with modifications. The motion passed 7-0, Commissioners Quartararo, Daly, Foster, Kasparowitz, Schultz, Tustin and Warner in favor.

Public Hearings —

1. Ordinance Amendment A09-0004 City-wide Amendments to Title 24 of the Santa Cruz Municipal Code (Zoning Ordinance)

modifying definitions and amending other sections regarding alcohol sales and live entertainment. (Environmental Determination: Exempt from CEQA) (City of Santa Cruz, applicant).

RECOMMENDATION: That the Planning Commission recommend to the City Council approval of amendments to Title 24 (Zoning Ordinance) relating to modifications to the alcohol regulations with a finding that said amendments are in general conformance with the principals, policies and

land use designation set forth in the General Plan and any adopted area or specific plan which may be pertinent.

Associate Planner Nancy Concepcion presented the staff report.

- ➤ Possibility of clarifying the definition of 'High-Risk Alcohol Outlet' by the substitution of 'and/or' instead of 'or' after the words 'banquet facility' and before the word 'premise';
- ➤ Which situations would trigger the requirement of a new permit;
- ➤ What 'queuing of patrons' means in terms of the management plan required, and its parameters;
- ➤ Whether requirements for a bonafide restaurant are still in the regulations and at what percentage;
- ➤ How established businesses would be affected by new regulations, including increase in fees;
- > The high number of calls for service on current low-risk outlets;
- ➤ Ventilation requirements and noise issues; and
- > Definition of 'major extension of hours' and how that is determined.

<u>ACTION:</u> Commissioner Warner moved, and Commissioner Tustin seconded, that the Planning Commission recommend to the City Council APPROVAL of the amendments to Title 24 (Zoning Ordinance) relating to modifications to the alcohol regulations. The motion passed 7-0, Commissioners Quartararo, Daly, Foster, Kasparowitz, Schultz, Tustin and Warner in favor.

Appeals must be received by the City Clerk within ten (10) calendar days following the date of the action from which such appeal is being taken. An appeal must be accompanied by a five hundred dollar (\$500) filing fee, unless the item involves a Coastal Permit that is appealable to the Coastal Commission, in which case there is no fee.
