Minor Modification to Special Use Permit/Design Permit SUP/DP83-79 and Administrative Use Permit to allow a coffee vending cart at an existing bed-and-breakfast in the RT(C)/CZ-O zone district (Environmental Determination: Categorical Exemption) (Coastal Permit Exclusion) (Shahin Gutierreez, owner/filed: 5/28/2009)

RECOMMENDATION: That the Planning Commission acknowledge the environmental determination and approve the Minor Modification and Administrative Use Permit, based on the findings in the staff report and the Conditions of Approval listed in Exhibit "A".

Principal Planner Marlatt introduced Associate Planner J. Lum, who presented the staff report.

The Planning Commissioners asked questions and expressed concerns regarding:

- > Signage
- Parking
- Storage for bicycles
- ➤ Language to prohibit sub-leasing of cart
- ➤ Covering for cart (currently a blue tarp)
- > Preference for options other than permit parking
- ➤ Whether the cart is available for the public or only registered guests
- > The longer term rentals in the rear

The Public Hearing was opened.

Maria Gutierrez, mother of the owner, spoke regarding the project and answered questions from the commissioners.

Shahin Gutierrez, owner, spoke about the project and his desire to exhibit art at the Bed and Breakfast.

The Public Hearing was closed.

The Commissioners made comments regarding the project. They thought it was a creative idea as well as a public benefit and a good fit for the beach area. Concerns were voiced about the potential health and safety issues associated with the two rear units that are currently being rented on a long term basis, the appearance of the cart covering and signage, and the use of parking permits.

Principal Planner Marlatt suggested that concerns regarding the rear rental units could be satisfied by an inspection of those units and that signage and the covering for the cart would be subject to staff approval.

<u>ACTION</u>: Commissioner Kasparowitz moved, and Commissioner Daly seconded, that the Planning Commission APPROVE the Minor Modification and Administrative Use Permit with the additional conditions that extended hours may commence on Memorial Day, the coffee cart cannot operate as a "bona fide restaurant" as defined in the Zoning Ordinance, the two rear rental units be inspected by the Building Division prior to commencement of the coffee cart use and that all signage and weather covering for the cart be subject to a Design Permit. The motion passed 6-0 with Commissioners Quartararo, Daly, Foster, Kasparowitz, Warner and Tustin in favor.
