

PUBLIC SAFETY COMMITTEE REGULAR MEETING

Minutes of March 15, 2010

I. Chair Robinson called the meeting to order at 4:04 p.m. in the Courtyard Conference Room of City Hall.

II. Public Comment on Items Not on the Agenda

There was no public comment.

III. Approval of the Minutes of the December 7, 2009 Meeting

Councilmember Lane moved, seconded by Chair/Councilmember Robinson, to approve the minutes of December 7, 2009 with a correction to the public comment. The motion carried unanimously with Mayor Rotkin absent from the vote.

IV. Youth Safety Update

Chair/Councilmember Robinson provided an update on some student and teen projects that have occurred since the Youth Safety Dialogue. Chair Robinson stated that this will be a future agenda item.

V. City Parks and Open Space Public Safety Update

Chair/Councilmember Robinson introduced the item as focused on public safety – fire and police – in the lower DeLaveaga Park and Carbonera areas. Fire Prevention Inspector Parker provided a summary of coordinated fire response and discussed some of the fire dangers in the area. Police Captain Clark described some of the crime trends and police response. The Committee discussed coordination of resources across agencies. Chair Robinson stated that this would be a future agenda item.

VI. Review of Joint Committee on Sexual Assault Recommendations

Chair/Councilmember Robinson introduced the item and discussed her understanding of the Joint Committee's recommendations. CPVAW Coordinator Agnone provided a summary of CPVAW's actions and updates to the City Council to date on the recommendations.

Gillian Greensite asserted that a few of the recommendations should be more precisely worded, such as with respect to the type of police investigative training, and that the City was to facilitate meetings between involved agencies.

CPVAW Chair M. Watkins discussed CPVAW prevention efforts and indicated that the Commission actively reviews data trends and has subcommittees that are proactively working on various topics.

The Committee took no action.
