# Public Hearings —

1. Alley behind 1900-1926 Soquel Avenue CP10-0108 NO APN
Partial Abandonment of public easement over alley between Park Way South and Mentel
Avenue; and abandonment of a public easement over a six-foot-wide by 308-foot-long
section on north side of alley (1,848 square feet) in connection with Soquel Avenue rightof-way needed for Soquel/Park left-turn lane and other street improvements.
(Environmental Determination: Categorical Exemption) (Owners/Filed: City of Santa
Cruz and Futura Investments/6-28-2010)

**RECOMMENDATION:** Recommend approval of partial abandonment to City Council.

Assistant Director Khoury introduced Senior Planner Lauritson who presented the staff report, then introduced Assistant Public Works Director Schneiter for comments and a description of the street improvement project creating the need for the partial abandonment.
