1. 1930 Ocean Street Ext. CP10-0033 APN 008-044-02

Design and Planned Development Permits and Tentative Map to construct a 40-unit apartment/condo development within 10 four-unit buildings. The project also requires a General Plan Amendment to change the land use designation of 2.74-acre parcel from L (Low Density Residential) to LM (Low Medium Density Residential) and a Zoning Map Amendment to rezone from the property from R-1-10 (Single-Family Residential) to RL (Multiple Residence – Low Density). RECOMMENDATION: That the Planning Commission continue the application to the December 2, 2010 meeting.
