Design and Planned Development Permits and Tentative Map to construct a 40-unit apartment/condominium development within 10 four-unit buildings. The project also requires a General Plan Amendment to change the land use designation of 2.74-acre parcel from L (Low Density Residential) to LM (Low Medium Density Residential) and a Zoning Map Amendment to rezone the property from R-1-10 (Single-Family Residential) to RL (Multiple Residence – Low Density). ➤ Peter Pethoe – spoke about inadequate sewer collection in the area; certain parcels within City limits are on septic system. Also spoke about 'spot zoning' of parcels being problematic.

Principal Planner Marlatt reminded the Commission that the item had been continued after the public hearing was closed, and that it would be up to the Commission to re-open the hearing if they wanted to take additional public testimony when the project is back on the agenda. He also advised that should this item move forward, it would need to go before the City Council where it would get another public hearing.
