## Subcommittee/Advisory Body Oral Reports

1. City of Santa Cruz/Soquel Creek Water District Joint Desalination Task Force (Meyers)

The Task Force approved the scope of work for hydraulic modeling to move desalination water to the Soquel Creek Water District that is necessary to inform the EIR and a scope of work for the next two phases of work on the Energy Minimization and Greenhouse Gas Reduction Study at its January meeting.

Commissioner A. Schiffrin volunteered to be the Water Commission alternate representative.

## **Director's Oral Report**

1. Monthly Status of Water Supply

There was nothing further to report.

2. Desalination Program

The Intake Feasibility Study is in final review by the technical working group and will be presented to the task force in April. It will be used to inform the EIR.

The comment period closed on January 10, 2011 on the Notice of Preparation/Initial Study. Fifty-nine (59) written and thirty-two (32) verbal comments were received. A scoping document that provides a detailed account of the public scoping process is available at <a href="www.scwd2.org">www.scwd2.org</a>.

The public meeting on Energy has been postponed until the energy study is complete. The final scope to complete the energy study will be presented at the February Task Force meeting.

The facility design continues to move forward. Next step is presentation of a recommended reverse osmosis system configuration at the March Task Force meeting.

The transmission main evaluation has begun which will look and inform the EIR on the various alignments and improvements associated with moving/pumping raw seawater, brine, and treated water.
