Water Commission Comments

The Water Supply Assessment is very compelling but also very speculative and the function of the document is very limited. It highlights the need for continued water conservation and the need to build a water supply project.

The Commission requested that the Habitat Conservation Plan report come to the Water Commission for review.

Commissioner A. Schiffrin moved to recommend that City Council approve the Water Supply Assessment and requested that information about the HCP process being presented the following day to City Council be transmitted to the General Plan EIR consultant so that it can be incorporated into the General Plan EIR. It was further requested that staff provide the Commission with copies of the City's adopted Water Conservation Plan and the California Urban Water Conservation Council MOU, and that in 3 months or after the completion of the Urban Water Management Plan, that staff provide the Commission with an update for considering potential additional programs and developing the next generation water conservation plan. Commissioner G. Mead seconded.
