Statements of Disqualification — Commissioner Mesiti-Miller advised that he met with George Ow and Jeffrey Dunn and the subject of Walgreen's (201 Front St) came up. Although he advised them he couldn't discuss the item prior to the hearing, they did talk a bit about the background of the project. He spoke with Planning Director Rebagliati who spoke with City Attorney Barisone about the conversation and was advised that no misconduct had taken place.

Approval of Minutes — April 7, 2011

ACTION:

Commissioner Quartararo moved, and Commissioner Kennedy seconded, that the Planning Commission APPROVE the minutes of April 7, 2011 as presented. The motion passed 5-0-1-1, with Commissioners Foster, Kennedy, Quartararo, Schultz and Tustin in favor, Commissioner Mesiti-Miller abstaining and Commissioner Whatley absent.

Public Hearings —

1. 201 Front St CP11-0035 APN 007-031-01

Administrative Use Permit for a low-risk alcohol outlet and a Design Permit for the remodel of an existing commercial building including new signs in the CBD-E zone district. (Environmental Determination: Categorical Exemption) (Ow, George Jr. Trustees et al, owner/filed: 3/9/2011)MF RECOMMENDATION: That the Planning Commission acknowledge the environmental determination and approve the Administrative Use and Design Permits based on the Findings and Conditions of Approval.

Associate Planner Ferry presented the staff report. He advised that the applicant requested an extension of hours from a 10 p.m. close time to an 11 p.m. one. Since the Police Department didn't have any issue with this, staff is recommending a change to Condition #22 to show the hours as 8:00 a.m. to 11:00 p.m. seven days a week.

The Applicant's representative, Jeff De Voe, spoke about the project and answered Commissioners' questions. He also submitted a letter with proposed changes they'd like to see to conditions #10 and #17.

The public hearing was opened.

The public hearing was closed.

The Commissioners asked questions and made comments in regards to the following:

- ➤ Possible earlier opening time
- Multitude of windows; potential of too much sign coverage on windows
- > Pedestrian access points, especially near levee
- Landscaping, the green screen wall, possible mural, trees in area, trash enclosure lighting
- > Keeping exposed ceiling to view bow-string trusses
- > Reader-board cycle times
- Encouraging applicant to use Green Building practices, solar panels, etc.
- ➤ Need for an anchor tenant in area; security concerns

Paul Stevens with Hawkins Company, the project developer, answered Commissioners' questions.

Chair Tustin wanted the record to show she is against the electronic message board, but will not vote against the project for that reason.

ACTION:

Commissioner Schultz moved and Commissioner Quartararo seconded, that the Planning Commission acknowledge the environmental determination and APPROVE the Administrative Use and Design Permits based on the Findings and Conditions, with modifications to Condition # 10 to allow removal of the green screen if structurally necessary, working with staff on a suitable landscaping or wall covering replacement; to Condition #17 to allow the

electronic message board, with flashing to be no less than 1 minute in duration; to Condition #22 to show open hours of 8:00 a.m. to 11:00 p.m., with flexibility on opening up to an hour earlier upon review by staff and the Police Department, and adding conditions that the applicant work with staff on window sign coverage limitations; and urging applicant to contribute to pedestrian path reconstruction fund. The motion passed on a vote of 6-0-1, with Commissioners Foster, Kennedy, Mesiti-Miller, Quartararo, Schultz and Tustin in favor, and Commissioner Whatley absent.

A break was called at 8:38 p.m., and the Commission reconvened at 8:45 p.m.

2. 201 West Cliff Drive CP10-0117 APN 004-091-26

Appeal of the Zoning Administrator's approval of a Coastal Permit to recognize the removal of five Heritage Trees in the OF-R zone district. (Environmental Determination: Statutory Exemption (15269 Emergency Projects) (Santa Cruz Seaside Company, owner/filed: 7/8/2010)MF This project requires a Coastal Permit which is appealable to the California Coastal Commission after all possible appeals are exhausted through the City.

RECOMMENDATION: That the Planning Commission acknowledge the environmental determination and deny the appeal, upholding the Zoning Administrator's approval of the Coastal Permit based upon the Findings and the Conditions of Approval.

Associate Planner Mike Ferry presented the staff report and advised the Commission that, although he had assured the Appellant that an overhead projector would be available for use at the meeting, he had been unaware that said projector had been removed from the chambers a few weeks prior. He apologized for the error.

Appellant Gillian Greensite requested a postponement so that she could prepare another presentation for the Commission that didn't necessitate the use of the projector.

Merry Crowen from Seaside Co (original applicant) requested the item be put first on any future agenda.

ACTION:

Commissioner Quartararo moved, and Commissioner Foster seconded, that the Planning Commission CONTINUE the item to a date to be determined by staff. The motion passed on a vote of 6-0-1, with Commissioners Foster, Kennedy, Mesiti-Miller, Quartararo, Schultz and Tustin in favor, and Commissioner Whatley absent.
