1. Domestic Violence Statistics from SCPD

ACTION: Commissioner Christie made a motion, seconded by Commissioner Johnson, to accept the report on Domestic Violence statistics with the correct 2010 report to be provided by CPVAW staff. The motion passed unanimously.

2. Statistical reports regarding Sexual Assault from CPVAW

Recommendation --- Accept, by motion, report on Sexual Assault 2010 statistics and provide direction to staff as appropriate.

ACTION: Commissioner Tobisch made a motion, seconded by Commissioner Johnson, to accept the 2010 statistical report on sexual assault data. The motion passed unanimously.
