2. SCWD<sup>2</sup> Energy Status Reports No. 2, 3, 4, 5 and Proposed Evaluation Criteria

Water Director Kocher introduced Desalination Program Coordinator H. Luckenbach and Assistant Engineer S. O'Hara who provided an oral report on the Energy Minimization Study and Greenhouse Gas Reduction Study (Energy Study).

#### Commission comments

The public should be aware that other alternatives that are being mentioned are being studied extensively in the EIR. This has been a very long process and the EIR is the document that informs the decision making process.

No action was taken on this item.

3. Urban Water Management Plan Update

Water Conservation Manager T. Goddard provided the staff report and answered commission questions.

Members of the public were encouraged to provide written comments to staff.

#### **Commission Comments**

Page 2-4 rainfall data is provided for the City of Santa Cruz and it would be helpful to provide rainfall data for the watershed

Page 3-4 discussion of Loch Lomond water rights should include increasing it to equal the storage amount (1,825 mgy)

Page 3-14 include a discussion of why the Department of Water Resources has not identified the Purisima aquifer to be in "overdraft."

Pages 4-2 include a discussion of demand hardening and include charts that provide information on "peak season" in order to aid the lay person understand the magnitude of a drought shortage. Page 4-19 include a discussion of the assumptions used for University of California demand for 2020 - 2030 (see I-3).

## Chapter 10 General Plan Polices

CC3.1.3 add if it is environmentally acceptable and financially feasible.

CC3.3.3 add seek amendment of the City's water right to provide increased flexibility for use of permitted water while assuring environmental safeguards.

CC3.3.7 add as well as protect environmental resources

CC3.5 add a program that implements additional conservation programs that provide a reliable gain to water supply and are cost-effective.

CC3.6.4 ask that staff provide information about a threshold of significance for water projects that would be used in a consistent basis for commission review.

Tables 5-4 and 5-5 illustrate the impacts of the Habitat Conservation Plan and just how much additional water will be needed to meet a peak season shortage of no more than 15%.

The discussion of the aging infrastructure could be expanded.

Commissioner A. Schiffrin moved that the Urban Water Management Plan Update be continued to the November 7, 2011 meeting and request that staff respond to commission comments and written comments from the public. Commissioner B. Fouse seconded.

# 1. Monthly Status of Water Supply

Director Kocher reported that the reservoir is at about 90% capacity and that the San Lorenzo River if flowing in excess of 15cfs and demand is below 10 mgd.

## 2. Desalination Program

The major areas of work continues to be the development of the dEIR. The Conceptual Intake Design Study is complete and will be used to inform the dEIR. The Energy Study continues to be a very big work item. A community meeting on Energy Issues is scheduled for December 8, 2011. The intertie analysis is almost complete.
