**INFORMATION:** On December 8, 2011 at approximately 7:15 am, Santa Cruz Police Department officers were joined by Santa Cruz Parks and Recreation and Public Works staff, Santa Cruz County Sheriff's Office, Capitola Police, Watsonville Police, Scotts Valley Police, UCSC Police, Capitola Police and State Parks officers in finalizing the evacuation order for Occupy Santa Cruz's encampment. Six people were arrested during the clearing of the encampment and no one was injured.

All of the arrestees face \$25,000 in bail except Mr. Wilhelmy who faces a \$50,000 bail amount. Most of the arrests were for obstruction or delaying officers while in their duties. Ms. RipleyPhipps was arrested for obstructing officers. She was also the media liaison/spokesperson for the 75 River Street takeover.

Parks staff said approximately 8 tons of trash was taken from the encampment and at least \$5,000 in damage was done to the benchlands. In addition, they estimate between \$15,000-20,000 in staff costs were associated with cleaning the encampment over the course of the occupation. Police department costs have not been calculated at this point.
