Recommendation --- Approve, by motion, the minutes from the monthly meeting of August 3, 2011 as submitted. ACTION: Commissioner Tobisch made a motion, seconded by Chair Watkins, to approve the August 3, 2011 minutes as submitted. The motion passed unanimously (Commissioners Babcock & Christie abstained due to absence at Aug meeting; Commissioner Polanco absent)

1. <u>Annual Public Hearing/30th Anniversary Celebration</u>

Recommendation – Discuss plans for Annual Public Hearing/30th Anniversary Celebration, funding amounts, and, by motion, approve final plans. which will include an afternoon reception, presentation by CPVAW and local agencies, and opportunity for community members to speak to Commissioners. ACTION: Commissioner Johnson made a motion, seconded by Commissioner Comstock, to ask the Chair, Vice Chair, and Coordinator to meet to finalize the list of awards to be presented at the Annual Public Hearing/30th Anniversary Recognition on October 5. The motion passed unanimously (Commissioner Polanco absent).

2. Women's Crisis Support – Defensa de Mujeres Annual Reception
Recommendation – Review invitation to WCS-DdM Annual Reception, and by motion, designate
CPVAW representatives to attend at a cost of \$35 per person. ACTION: Commissioner
Comstock made a motion, seconded by Commissioner Christie, to approve funding to
attend WCS-DdM Reception event on Thursday, September 29 at Bargetto's Winery from
5:30-8 pm. The motion passed unanimously (Commissioner Polanco absent).

3. Domestic Violence Month Plans

Recommendation – Review activities and discuss ideas for 2011 DV Awareness Month activities to partner with other commissions/agencies, approve total budget, and, by motion, other action as needed. ACTION: After reviewing activities for the month, Commissioner Babcock made a motion, seconded by Commissioner Comstock, to approve funding up to \$700 for Domestic Violence Awareness Month (which includes \$200 previously approved and \$500 for Annual Public Hearing/30th Anniversary events). This motion will provide up to \$700 of funding for all DV month events. The motion passed unanimously (Commissioner Polanco absent)

4. Spreadsheets for Sexual Assault Data

Recommendation – Review revised data spreadsheet from CPVAW Police Committee and, by motion, approve revisions as indicated. **ACTION: Commissioner Johnson made a motion**, seconded by Commissioner Tobisch, to approve suggested changes to the data spreadsheet as recommended which include day of week, time, definitions of abbreviations, better use of current columns, and suggested responses for some columns. he motion passed unanimously (Commissioner Polanco absent)

Commissioner Tobisch reminded members of the Santa Cruz Neighbors Block Party events on Sunday, October 2.

Commissioner Christie commented that she was happy to hear that the Wyndham Hotels have signed the code of conduct for the Protection of Children from Sexual Exploitation in Travel and Tourism.
