Approval of Minutes

Minutes of September 7, 2011 and October 5, 2011 Annual Public Hearing Notes (FYI: November 2, 2011 meeting cancelled)

Recommendation --- Approve, by motion, the minutes from the regular monthly meeting of September 7, 2011 as submitted.

ACTION: Commissioner Comstock made a motion, seconded by Chair Watkins, to approve the September 7, 2011 minutes as submitted. The motion passed unanimously (Commissioner Polanco abstained, Commissioner Babcock absent).

Recommendation --- Accept, by motion, the notes from the annual public meeting of October 5, 2011 as submitted.

CPVAW Meeting of December 7, 2011

ACTION: Commissioner Christie made a motion, seconded by Commissioner Tobisch, to accept the October 5, 2011 notes as submitted. The motion passed unanimously (Commissioner Polanco abstained, Commissioner Babcock absent).

General Business

1. Annual Public Hearing/30th Anniversary Celebration Follow Up

Recommendation – Discuss Annual Public Hearing/30th Anniversary Celebration scheduled on October 5, 2011, review information regarding art project and form ad hoc to develop final plans, discuss tree dedication for gingko grove, and, by motion, take action as necessary.

ACTION: Commissioner Christie made a motion, seconded by Commissioner Johnson, to form an ad hoc committee to develop plans for the art project to update the CPVAW poster. The motion passed unanimously (Commissioner Babcock absent).

Commissioner Comstock volunteered to work with CPVAW Coordinator regarding plans for the tree dedication.

2. Calendar of Meetings for 2012

Recommendation – Review dates for 2012 CPVAW meetings, discuss alternative for July 2012 date, and, by motion, take action as necessary.

3. Reprinting of Resource Materials

Recommendation – Review issues of reprinting of Safe Place Network Resource Cards, Coasters, Homeless Women's Resource Cards, Bookmarks, and other handouts and, by motion, take action as necessary.

ACTION: Commissioner Comstock made a motion, seconded by Commissioner Christie, to reprint the Homeless Women's Resource Cards and the Bookmarks with the corrected hotline number. The motion passed unanimously (Commissioner Babcock absent).

4. Ad hoc committees

Recommendation – Review ad hoc committees that have sunset (which have not met due to CPVAW Coordinator's absence) and, by motion, take action to re-establish as necessary.

ACTION: Commissioner Johnson made a motion, seconded by Commissioner Polanco, to re-establish the Joint Report on Sexual Assault ad hoc with the same members in order to complete the report by April 2012. The motion passed unanimously (Commissioner Babcock absent).

5. Funding for Domestic Violence/Child Abuse Workshop

Recommendation – Review information regarding workshop scheduled for January 13, 2012 at Cabrillo College which will bring Dr. Daniel Jay Sonkin as key speaker and, by motion, take action regarding funding as needed.

Leslie Hartman from the United Way/Child Abuse Prevention Council presented information to Commissioners regarding the workshop. Present contributors include the United Way, Head Start, SC County Human Services, and Women's Crisis Support-Defensa de Mujeres.

ACTION: Commissioner Comstock made a motion, seconded by Chair Watkins, to contribute \$250.00 towards the costs of the Jan 2012 workshop. The motion passed unanimously (Commissioner Babcock absent).

6. National Conference on Health and Domestic Violence (NCHDV)

Recommendation – Review information regarding March 2012 conference in San Francisco sponsored by Futures Without Violence (formerly Family Violence Prevention Fund) presented to spotlight domestic violence issues, and, by motion, take action as necessary.

ACTION: Commissioner Johnson made a motion, seconded by Commissioner Polanco, to approve funding for one CPVAW member to attend the conference (registration and room) in March 2012 contingent upon cancellation policies. The motion passed unanimously (Commissioner Babcock absent).

7. Support for "One Million Safer Kids" Campaign

Recommendation – Review information regarding Kidpower's call to action and, by motion, take action as necessary.

ACTION: Commissioner Christie made a motion, seconded by Chair Watkins, to direct Coordinator Agnone, on behalf of CPVAW, and individual Commissioners as desired, to respond to Kidpower's Call to Action Campaign via their website. The motion passed unanimously (Commissioner Babcock absent).

8. Funding for Kidpower and "Storytelling for Good" Video

Recommendation – Review information regarding Kidpower's plans to work on a video with "Storytelling for Good" and, by motion, take action regarding funding level as needed.

ACTION: Commissioner Polanco made a motion, seconded by Chair Watkins, to contribute \$100.00 towards the costs of the video work being done by Kidpower and the Storytelling for Good organizations. The motion passed unanimously (Commissioner Babcock absent).
