INFORMATION:

On Thursday, December 29, 2011 at approximately 4:00 pm, Santa Cruz police officers served a drug related search warrant at a residence in the 100 block of Manor Place. The officers searched the residence and found narcotics packaging as well as drug paraphernalia. There were four people inside the residence who were under the influence of a controlled substance including Maureen May, Harvey Behrendt, Ryan May and Sandra Wujcik.

Ms. May was arrested for being under the influence of drugs, possession of drug paraphernalia and presence in location of unlawful drug use. Mr. Behrendt was arrested for being under the influence of drugs, possession of drug paraphernalia, maintaining a location for unlawful drug use and elder abuse because he knowingly placed an elderly relative in a situation where her health could have been in danger due to the illegal drug activity which was taking place at the residence. Mr. May and Ms. Wujcik were arrested for being under the influence of drugs and presence in location of unlawful drug use.
