1. 2012 Water Commission Calendar

2. SCWD² Energy Status Report No. 6

Director Kocher provided the staff report and answered Commission questions on this item.

Commission Comments

Commissioner Schiffrin reported as the Commission representative that only 11 projects made it through the feasibility screening and that he has prepared an energy savings summary spreadsheet to share with the Commission and the Task Force.

It would be helpful to provide information on how much energy the plant will be using when it is running at 100% capacity.

It is important that the projects be local and preference should be given to projects within the City Water Department and the Soquel Creek Water District if possible.

No action was taken on this item.

3. Urban Water Management Plan (UWMP) Update

Water Conservation Manager T. Goddard reported that it is staff's opinion that this document more than meets the legal requirements set forth by the State. It is important to understand that the UWMP is a document that reports on the actions being taken by the City, not necessarily on potential actions that the City could take.

Written comments were received by six individuals and one agency. A summary of these comments have been provided. Several of the comments fall into the category of advocating for a different plan other the Integrated Water Plan. Other comments can be classified as information requests that would support water exchanges between neighboring agencies. These comments are not appropriate for the UWMP.

Public Comments were made by D. Stevens, R. Longinotti, S. Mcgilvray, M. Rand, P. Gratz, J. Ricker, M. Rotkin and J. Bentley.

Commission Comments

The Commission requested that the letter from Soquel Creek Water District in Support for a Possible Water Transfer Project between the City of Santa Cruz and Soquel Creek Water District be provided.

It is important to remember that the UWMP reports about a certain period in time. The update done in 2005 is out of date. It should provide the best factual information available at the time.

The City is committed to continue to pursue conservation in an aggressive manner. Over the last several years the City has had better than water neutral development. It is reasonable to incorporate some water conservation estimates and to report that conservation plays a role in keeping demand lower in future years.

The water transfer concept is being studied, with City cooperation. It may someday be a viable supply alternative but it seems a contradiction that the Soquel Creek Water District has sent a letter stating that it would transfer water to the City considering the state of the groundwater basins.

Commissioner A. Schiffrin moved to recommend that City Council pass a resolution to adopt the 2010 Urban Water Management Plan and to authorize the Water Department to file a copy with the California Department of Water Resources with the following amendments:

- 1. Page 10-2 General Plan action CC3.1.1 add wording to qualify the policy on desalination to stipulate it needs to be shown to be environmentally acceptable and financially feasible.
- 2. Page 10-4 General action CC3.3.7 regarding fisheries conservation, add wording that clarifies the City's concern for the environmental resource (fisheries) demonstrating the motivation for fisheries conservation is not just regulatory compliance.
- 3. Page 10-5 General Plan action CC3.5 Regarding maximum water use efficiency, add another action statement that commits the City to implementing additional water conservation programs that provides a reliable gain in water supply and that are cost-justified.
- 4. Include a more direct discussion regarding the role of additional water conservation in the balance between supply and demand in Chapter 4.
- 5. Add some narrative language in Chapter 5 that explains the reason the City is not analyzing Tier 3 HCP flows without desalination in any depth is because the extreme consequences of trying to provide those releases in a drought without supplemental supply would be impossible to achieve with curtailment.
- 6. Include some discussion in Chapter 6 of the relationship between the City's system development fees charged to new development and water conservation that is intended to help compensate for the impact on new water demands on the system.
- 7. Incorporate written comments received from the public into the plan.
