Chair Watkins announced a fundraiser for Women's Crisis Support-Defensa de Mujeres on January 31. Proceeds from dinner/drinks at Shadowbrook Restaurant will go to the agency.

## **Approval of Minutes**

ACTION: Commissioner Comstock made a motion, seconded by Chair Watkins, to approve the minutes from the December 7, 2011 meeting as submitted. The motion passed unanimously (Commissioner Babcock abstained due to absence at the meeting; **Commissioner Polanco absent at tonight's meeting.)** 

#### **General Business**

## 1. Election of Officers/Committee membership appointments

Recommendation – Review process for elections and take action as necessary, to elect officers and confirm assignments to ad hoc and stand committees as well as County Domestic Violence Commission. Chair Watkins opened the floor to nominations for Chair for 2012. Pat Christie was nominated.

ACTION: Commissioner Johnson made a motion, seconded by Chair Watkins, to close nominations for chair. The motion passed unanimously (Commissioner Polanco absent at tonight's meeting.)

A voice vote was called and Commissioner Christie was elected unanimously to be CPVAW Chair for 2012.

Newly elected Chair Christie presided over the call for nominations for Vice Chair. Kathryn Tobisch was nominated.

ACTION: Commissioner Comstock made a motion, seconded by Commissioner Babcock, to close nominations for Vice Chair. The motion passed unanimously (Commissioner Polanco absent at tonight's meeting.)

A voice vote was called and Commissioner Tobisch was elected unanimously to be CPVAW Vice Chair for 2012.

## 2. "Miss Representation" Documentary Screening

Recommendation – Review information in consideration of supporting the screening of the documentary, *Miss Representation*, in Santa Cruz, and, by motion, take action as necessary.

NO ACTION TAKEN. A planning meeting will be scheduled for interested parties in the near future and more information will be provided in February.

## 3. Walk a Mile In her Shoes event for April

Recommendation – Hear information regarding support of Women's Crisis Support-Defensa de Mujere event in April and, by motion, take action as necessary.

Kalyne Weissblatt and Dieter Rainmaker provided background information and answered questions.

ACTION: Commissioner Tobisch made a motion, seconded by Commissioner Johnson, to support this program by reserving the areas, participating in the event, and sending notices out to CPVAW distribution lists for the 2012 event scheduled for April 21. The motion passed unanimously (Commissioner Polanco absent at tonight's meeting.)

#### 4. Teen Dating Violence Awareness Month Plans

Recommendation – Hear information regarding Teen Dating Violence Awareness Month in February and, by motion, take action as necessary.

There will be a meeting on February 2, 2012 from 9 am -2 pm at the Community Foundation to bring together partners for discussions on "Our Youth, Our Community" to talk about youth related issues.

Jennifer O'Brien-Rojo provided background information and answered questions on a program developed by Futures Without Violence.

ACTION: Commissioner Johnson made a motion, seconded by Commissioner Babcock, to form an ad hoc committee to include discussion on the Coaching Boys to Men Program developed by Futures Without Violence which addresses teen dating issues.

The motion passed unanimously (Commissioner Polanco absent at tonight's meeting.) Ad hoc commissioners: Commissioner Johnson, Watkins, Babcock
