1. 138 Palmetta Street CP12-0116 APN 004-169-03
Administrative Use Permit to construct a 640 square foot detached accessory dwelling unit over a 739 square foot garage on a standard lot in the R-1-5/CZO zone district. (Environmental Review: Categorical Exemption). (Beronio, Carlo A. H/W JT et al, owner/filed: 7/16/2012) MF

Design Permit for additions to a detached gazebo on a site with a single-family dwelling which results in a development that exceeds 3000 square feet in an R-1-5 zone district. (Environmental Determination: Categorical Exemption) (Basu, Dilip K. & Dayani K. Trustees, owner/filed: 7/16/2012)
