4. The development of the site shall be in substantial accordance with the approved plans submitted and on file in the Department of Planning and Community Development of the City of Santa Cruz. This approval includes guardrails to be constructed around the perimeter of the deck as required by the building code which may exceed the height of the rear yard fence. All aspects of construction must be completed prior to occupancy. Major modifications to plans or exceptions to completion may be granted only by the City authority which approved the project.
