#### Approval of Minutes – Minutes of October 18, 2012.

ACTION: The minutes of October 18, 2012, were APPROVED with the change of "to" in the second bullet point of the Action to "from" on a vote of 6-0-1 with all Commissioners voting in favor and Commissioner Kennedy absent.

# Public Hearings -

- 1. 272 De Laveaga Park Rd. CP12-0053 APN 009-051-75 Planned Development Permit to include modified site area standards and lot standards, Tentative Subdivision Map for a 13-unit subdivision with one common lot, and a Design Permit to construct 13 homes in the R-1-5 zone district. (Environmental Determination: Categorical and Statutory Exemptions) (Starr, Richard R. S/M, owner/filed: 4/4/2012) MF **RECOMMENDATION:** That the Planning Commission recommend to the City Council acknowledgment of the environmental determination and approval of the Planned Development, Design Permits, Heritage Tree Removal and Tentative Subdivision Map for a 13-unit subdivision in the R-1-5 zone district, based on the Findings in the report and the Conditions of Approval.
- ACTION: The Planning Commission RECOMMENDED that the City Council acknowledge the environmental determination and <u>approve</u> the Planned Development, Design Permits, Heritage Tree Removal and Tentative Subdivision Map with the following changes:
  - Change Finding #20 first sentence to read: The project includes a functional two car garage for each unit. and a side or rear yard for all single family dwellings.
  - Change Condition of Approval #4 to read: "Vertical-face type curbs, standard gutters and sidewalks shall be installed along all streets in the subdivision, in accordance with the approved tentative map, or another design as appropriate, subject to the approval of the Director of Public Works."
  - Change Condition of Approval #24 first sentence to read: "LID measures should include the following, or another design to meet the LID goals, subject to the approval of the Director of Public Works:"
  - Add Condition of Approval #59: <u>"For lots 1 through 8, effort shall be made to situate windows to avoid over-looking adjacent neighbors (i.e. higher window placement, frosted lower portions, change window locations, etc.)"</u>
  - Add Condition of Approval #60: <u>"The area occupied by the Water Easement between lots 4 and 5, exclusive of the vehicle turnaround, shall become part of lot 4 and shall be designed in such a manner as to provide maintenance and access needs of the Water Department, while considering privacy needs."</u>

The vote was 6-0-1 with all Commissioners in favor and Commissioner Kennedy absent.

An appeal must be accompanied by a five hundred dollar (\$500) filing fee, unless the item involves a Coastal Permit that is appealable to the Coastal Commission, in which case there is no fee.
