Green Building Ordinance A12-0004 City Wide Zoning Ordinance Amendment to Chapter 24.15 (Green Building Regulations) of the Santa Cruz Municipal Code and the Local Coastal Implementation Plan to update the City's Green Building Program. <u>APPEALS</u> - Any person who believes that a final action of this advisory body has been taken in error may appeal that decision to the City Council. Appeals must be received by the City Clerk within ten (10) calendar days following the date of the action from which such appeal is being taken. An appeal must be accompanied by a five hundred dollar (\$500) filing fee, unless the item involves a Coastal Permit that is appealable to the Coastal Commission, in which case there is no fee.
