1. 150 Jewell Street CP12-0076 APN 008-051-28 Major Modification of Site Supervision Permit No. SS-65-18, Minor Land Division, Slope Variance and Special Use, Design, Conditional Fence, and Sign Permits for a two-story memory care facility with 51 residential units located at the existing Elk's Lodge property in the R-1-5/RM zoning district. <u>APPEALS</u> - Any person who believes that a final action of this advisory body has been taken in error may appeal that decision to the City Council. Appeals must be received by the City Clerk within ten (10) calendar days following the date of the action from which such appeal is being taken. An appeal must be accompanied by a five hundred dollar (\$500) filing fee, unless the item involves a Coastal Permit that is appealable to the Coastal Commission, in which case there is no fee.
