General Business

1. Water Conservation Master Plan – Screening of Existing and Potential New Measures

T. Goddard, Water Conservation Manager provided the staff report. Mr. Goddard and Bill Maddaus both responded to Commission questions.

Oral Communications were made by R. Pomerantz and S. McGilvray.

Commission Discussion/Comments

The commission requested that staff provide information on the public education component.

In response, Water Conservation Manager Goddard reported that public education is an important component of the conservation program; it always has been and will continue to be. Public education cannot be quantified in gallons. The shape and direction it will take is undetermined at this time but all ideas are under consideration. The most common public input was about education topics.

Provide an opportunity for any member of the public who would like to discuss the process.

The Commission requested that staff provide a recommendation on the five additional programs to be included in the modeling: 1. Ultra-high/high efficiency toilets rebate or direct install – commercial/industrial/institutional sector; 2. weather-based irrigation controllers; 3. rain-sensors; 4. rainwater catchment rebates - larger systems; and 5. graywater (exterior).

Commissioner D. Baskin moved to 1) confirm the top 25 ranked water conservation measures based on the screening analysis for additional modeling; 2) include the following additional measures, ultra-high/high toilet rebates/direct install in commercial sector, weather-based irrigation controllers, rain-sensors, rainwater catchments rebate program for large scale systems and gray water; 3) request that staff meet with interested members of the public to explain the process used for rating the measures and consider additions within the next two weeks; and 4) provide a discussion/explanation in the final conservation plan of the relationship between water rates and conservation. Commissioner L. Wilshusen seconded.

2. Draft Residential and Commercial Baseline Water Use Survey

Water Conservation Manager T. Goddard provided the staff report and responded to commission questions. He acknowledged Environmental Project Analyst A. Martin for her work on this project. The presentation will be included in the original papers.

Commission Comments

The staff report to City Council should be written as an executive summary and be sure to highlight areas that Santa Cruz is far ahead of the statewide average. It should be noted that Santa Cruz measures up exceptionally well compared to other service areas. For example, statewide average for clothes washers is 30% in Santa Cruz 63%.

The Commission requested a report on remaining conservation opportunities for faucets, showerheads, toilets and dishwashers in terms of if it realistic to achieve 95- 100% saturation, how much water would be saved and how what it would cost.

Can 15% curtailment as called for in the Integrated Water Plan be achieved and if so what are the consequences? Relate this information to the assumptions made during the Integrated Water Planning Process.

3. Desalination Project Financial Analysis

Principal Management Analyst P. Harmon and S. Gaur, Raftelis Financial Consultants Inc. provided the staff report and responded to Commission questions. The presentation will be included in the original papers.

Commission Comments

It has been expressed by members of the public that it is possible to reduce demand even further with an aggressive conservation plan.

The Commission requested a demonstration of the model at a future meeting and that this item be included as an informational item for the July meeting if possible.

4. Santa Cruz Municipal Code - Revisions to Chapter 16.05 Loch Lomond Recreation Area

Water Director Kocher provided the staff report and responded to Commission questions.

The commission discussed that changing the hours during the middle of the season may cause negative impacts to visitors and requested that staff revise.

16.05.030 Add a section on the annually designated schedule that said during this period check with Department for availability.

16.05.050 (b) add by the Department.

16.05.060 (d) change to The use of any live bait unless approved by Department.

16.05.100 (h) add native

Commissioner W. Wadlow moved to continue this item to the June 3, 2013 meeting and request that staff make revisions based upon the Commission comments. Commissioner D. Baskin seconded.
