1. 711 Pacific Avenue CP13-0026 APN 007-021-06 Administrative Use Permit to establish a low-risk alcohol establishment (restaurant/sports bar with a Type 47 license) in a two-story building previously occupied by a high-risk alcohol establishment on the first floor (bar with a Type 48 license) and hotel rooms on the second floor, and to re-establish a non-conforming parking demand in accordance with Section 24.18.070.1 of the Zoning Ordinance. Property is located in the CB-D(E) zone district. (Environmental Determination: Categorical Exemption)(Lee, Calvin Quon Jr. & Tina Yim, owners/filed: 3/11/2013) NC Recommendation: That the Zoning Administrator continue this item indefinitely.
