Approval of Minutes —

seconded, approval of the Minutes of February 7, 2013, as submitted. The motion carried on a vote of 5-01-1, with Commissioners Primack, Kennedy, Nortz, Quartararo and Mesiti-Miller in favor, Commissioner Tustin abstaining, and

Commissioner Goncharoff absent.

Minutes of February 21, 2013.

ACTION: Commissioner Mesiti-Miller moved, and Commissioner

Primack seconded, approval of the Minutes of February 21, 2013, as submitted. The motion carried on a vote of 4-0-2-1, with Commissioners Mesiti-Miller, Primack, Quartararo

and Kennedy in favor, Commissioners Tustin and Nortz abstaining, and Commissioner Goncharoff absent.

# Public Hearings —

1. 1321 River Street CP12-0196 APN 008-011-03 Special Use Permit for Medical Marijuana Dispensary in the IG zone district (Environmental Determination: Categorical Exemption) (Linkemyer, Harlan Eugene & Evel, owner/filed: 11/27/2012) MF RECOMMENDATION: That the Planning Commission acknowledge the environmental determination and consider the Special Use Permit based on the findings listed in the Staff Report and the Conditions of Approval.

Associate Planner Ferry introduced himself and presented the staff report. He explained the Ordinance changes adopted in 2010. He noted that he had received correspondence with regard to the project with 21 letters or emails opposed to the project and 12 letters or emails in favor.

The applicant, Dave Thompson, introduced himself, discussed the project, and answered questions.

The Public Hearing was opened. Speaking from the audience were:

- ➤ Jean Doerr, who read a letter signed by 17 nearby residents in opposition to the project;
- ➤ Larry Wolfsen, River Street resident, in opposition;
- Carol Foster, owner of the Pogonip Terrace Apartments, in opposition;
- Scott Harrison, River Street resident, in opposition and with concerns about traffic;
- ➤ Taylor Wolfsen, River Street resident, with concerns about traffic and ADA compliance;
- Cathy Puccinelli, nearby resident, in opposition;
- Arsen Tsolacky, security consultant for the collective, in support;
- Fred Antaki, realtor for the applicant, spoke about the difficulty of finding a site, and in favor of the project;
- ➤ Kirian Bahn, River Street resident 28 feet away, in opposition;
- Mike Schell, former public safety officer, in opposition;
- Emmalee Fox, River Street resident, in opposition;
- ➤ Barbara Booth, close friends with owner of the building, lease is strict, thinks this use will make area more secure and is in favor;
- Wayne Inman, manager of Pogonip Terrace Apartments, concerned about ownership of dispensary, in opposition;
- ➤ Kristine Castro, River Street resident, frightened in her home and opposed to the dispensary.

The Public Hearing was closed.

Dave Thompson, applicant, addressed some of the neighborhood concerns, and noted that the same concerns were raised when Greenway was approved and they have operated for eight years with no complaints. He believes that a second dispensary is necessary. He answered a number of questions.

Warren Berry, Police Department, spoke briefly in regard to safety, and noted that the conditions the department added addressed patient and neighborhood safety.

Rick Martinez, Deputy Police Chief, answered questions and noted that this is a high crime area. He clarified that the police department is neutral and does not support or oppose the project. He added that the police department will not be monitoring the security cameras at the project.

The Chair called for a break at 9:15 p.m. and the Planning Commission reconvened at 9:22 p.m.

ACTION: Commissioner Tustin moved, and Commissioner Nortz seconded, denial of the project. The motion carried on a vote of 4-2-1 with Commissioners Tustin, Nortz, Mesiti-Miller and Quartararo in favor, Commissioners Primack and Kennedy opposed, and Commissioner Goncharoff absent. The Public Hearing was closed, and the item was continued

to the meeting of May 2, 2013 with direction given to staff to bring back findings for denial.

2. Zoning Ordinance Amendment A13-0004 City-Wide A Local Coastal Plan Amendment and an ordinance of the City of Santa Cruz amending Title 24 of the Municipal Code, the Zoning Ordinance, to add Section 24.12.431, "Protection of Paleontological Resources," and to make other required changes to Section 24.12.430, "Protection of Archaeological Resources," per the General Plan 2030. (Environmental Determination: Exempt from CEQA) (City of Santa Cruz, applicant / applied: 3/22/2013) MK RECOMMENDATION: That the Planning Commission acknowledge the environmental determination and recommend to the City Council approval of the Local Coastal Plan Amendment and Zoning Ordinance amendment based on the Findings listed in the staff report.

ACTION: The Item was <u>CONTINUED</u> to the meeting of May 2, 2013, by Consensus.

3. Zoning Ordinance Amendment A13-0003 City-Wide A Local Coastal Plan Amendment and an ordinance of the City of Santa Cruz amending Title 24, Section 24.12.200 of the Municipal Code, the Zoning Ordinance, to exempt mixed-use development from covered parking requirements. (Environmental Determination: Exempt from CEQA) (City of Santa Cruz, applicant / applied: 3/22/2013) MK RECOMMENDATION: That the Planning Commission acknowledge the environmental review determination and recommend to the City Council approval of the Local Coastal Plan Amendment and the Zoning Ordinance text amendment based on the Findings in the staff report.
