# Minutes of the November 4, 2013 Water Commission Meeting

Item 2 - City Council Items Affecting Water

Commissioner G. Mead asked L. Almond, Interim Water Director to provide additional information on the Council's discussion of water supply for drought. L. Almond presented and reviewed councilmember Lane's letter to Council. She reported that staff is meeting to define the public process as well as the timeline and costs for other work plan tasks, and will likely bring those back to council at their 11/26 meeting.

L. Almond, Interim Water Director responded to commission questions.

### **General Business**

### 1. Large Landscape Water Budget Program Presentation

T. Goddard, Water Conservation Manager, provided a presentation on the Department's program that sets advisory water budget for large landscaped areas and tracks account holder actual water use against those guidelines. The program is advisory only and not yet linked to actual rates.

Oral Communications were made by S. McGilvray and P. Pethoe.

Summary of public comments:

- This Large Landscape Water Budget Program is an excellent program.
- The higher water uses included in this group have bulk rates. Changing them to tiered rates would provide greater economic incentives.
- Need to look at utilizing reclaimed water for golf courses.

T. Goddard, Water Conservation Manager acknowledged and thanked Aerin Martin, Environmental Project Analyst for coordination of this program.

Commission Discussion/Comments

- Commissioner Schiffrin asked for net cost per gallon saved by the program. T. Goddard stated that this information will be brought back to the commission.
- Staff offered that the gross cost of the program was approximately \$50.00 per customer, per year.
- Commissioner Baskin asked if water budgets create incentives for the public to use plants that are more drought tolerant. T. Goddard said it would if and when water budgets are linked to rates.

T. Goddard, Water Conservation Manager discussed monthly status of water supply passed written material will be included in the original papers.

**Director's Oral Report** No action shall be taken on this item.

1. Monthly Status of Water Supply

Oral and written communications were made by T. Goddard, Water Conservation Manager regarding the monthly status of the water supply.

Staff noted that Loch Lomond is at 69.5%, the lowest since 1997. This is due to two factors: 1.) We are leaving more water in the streams to support fisheries and 2.) dry weather.

2. Water Supply Project Update. No discussion.
