Coastal Permit to conduct annual dredging in Neary Lagoon to reduce sedimentation and increase lagoon depths in order to: 1) improve water circulation and flow rates; 2) improve water quality; 3) reduce the proliferation of vegetative (Tule) growth; 4) improve habitat; 5) provide access for the Tule removal equipment and to prevent the lagoon from "filling" up. Depending upon the accumulation of sediment over the winter months and resulting lagoon depths, up to 3,600 cubic yards of sediment may be removed each year that dredging is conducted. Dredging may be conducted annually if necessary for the duration of (the California Department of Fish and Wildlife) all applicable permits. (Environmental Determination: Mitigated Negative Declaration) (City of Santa Cruz, owner/filed: 3/27/2014) MF

*This project requires a Coastal Permit which is appealable to the California Coastal Commission after all possible appeals are exhausted through the City.
