Conditional Fence Permit to recognize 6 foot high vertical board fence on exterior side yard setback for a single family dwelling and accessory dwelling unit located in the R-1-5 zone district. (Environmental Determination: Categorical Exemption) (Maximilian Schultz, owner/filed: 11/3/2014) NC
