The Policy, as drafted, outlines a process for submitting an initial proposal to be reviewed by a subcommittee of the Arts Commission. If the subcommittee approves forwarding to the proposal to the entire Commission, the proposer must provide detailed information that addresses several review criteria.

4. Study Session Follow-up
