Director Rebagliati announced that the next meeting on December 3 will include an Appeal for a parks department par course piece on West Cliff Drive and an item continued from last meeting regarding Sea and Sand bluff repair and the Downtown Recovery Plan Phase II. The following meeting on December 17 will feature sign ordinance amendments and the Beach Flats garden project permits. In January a development agreement and perhaps design changes for 555 Pacific, and an appeal of a repair to East Cliff Drive and Shakespeare Santa Cruz at DeLavega, a mixed use housing project on Soquel and changes to the Delaware project and MAH. She also noted the second reading of zoning changes disallowing short term rental of ADUs will be on the City Council's agenda for Tuesday, November 24, and Council gave staff instructions to look at limiting short term rentals in residential neighborhoods. Additionally, the Water Supply Advisory Committee recommendations are coming to Council and staff is waiting on a traffic study for 1800 Soquel before it goes to Council.

<u>APPEALS</u> - Any person who believes that a final action of this advisory body has been taken in error may appeal that decision to the City Council. Appeals must be in writing, setting forth the nature of the action and the basis upon which the action is considered to be in error, and addressed to the City Council in care of the <u>City Clerk</u>.

Appeals must be received by the City Clerk within ten (10) calendar days following the date of the action from which such appeal is being taken. An appeal must be accompanied by a five hundred fourteen dollar (\$514) filing fee, unless the item involves a Coastal Permit that is appealable to the Coastal Commission, in which case there is no fee.
