 332 Plymouth St. CP15-0023 APN 008-142-04 Historic Alteration Permit to add 604 square feet to an existing 1,065 square foot residence listed on the City Historic Building Survey to result in a two bedroom, single story, single family dwelling: to relocate and reconstruct an existing 296 square foot accessory structure (garage) also listed on the City's Historic Building Survey; and to construct a 564 square foot detached two-car garage with an attached 311 square foot workshop with a half bathroom on the rear of the property. The property is located within the RL Zone District. # 2. HPC Veteran's Day Cleaning of the War Memorial located at the corner of Pacific Avenue and Front Street.
