Group discussed the possibility of a new performance art program. Several Commissioners liked the idea of a program addressing City Council goals on city property, as recommended by staff. Chair Allan thought it might improve connections with Council. Jim Brown thought that criteria (such as the six City Council goals) provide needed direction, eliminate duplication with the Arts Council grants, and are key for evaluating applications and possible performance spaces could include City Hall, East Side Parking lot, Riverwalk, Cooper St etc. Doug Hull did not want the criteria to be restricted to City Council goals.

Action: Group agreed to form a subcommittee to discuss further. Jim Brown, Doug Hull and Abra Allan will meet to discuss.




