Public Hearings -

1. La Bahia Hotel

215 Beach Street CP13-0059 APN 007-214-02 Recommendation to the City Council for Historic Demolition Permit, Historic Alteration Permit, and Historic Building Survey Deletion to demolish an existing 44-unit residential complex except for a portion of the southeast building containing the bell tower, and to construct a 165-room hotel with conference and banquet space, restaurant, retail space, underground parking, and spa facilities in the RTC/CZO/SPO zone district. (Environmental Determination: Environmental Impact Report) (La Bahia LLC, owner/filed: 5/20/2013) RB **Recommendation: Approval, with conditions.**

Senior Planner Bane presented the staff report.

Applicant Craig French of French Resources Group, spoke on behalf of the Seaside Company property owner. He introduced the project team consisting of Carl Rice of the Seaside Company, Architect Marsha Maytum of Leddy, Maytum & Stacy; and Landscape Architect, Joni Janecki of Janecki Design Group. He noted that this p:_public\packets\2014\hpc\08-13-14_spmtg_la bahia hotel\08-13-14.actionminutes final approved.doc Approved by HPC 10-15-14 project fulfills goals of the 2030 General Plan, the Local Coastal Plan and the Beach and South of Laurel Comprehensive Area Plan which call for development of the site for a conference hotel which will promote tourism and improve the Beach Area as a major ocean-front resort destination. He noted that the project preserves and incorporates the La Bahia bell tower corner of the site into the project; and, the project's many benefits outweigh its impacts. He noted that the architect and the design team and Teiflon Rice-Evans of the Economic and Planning Systems firm were there to answer questions of the Commissioners.

Architect Marsha Maytum presented a slide presentation on the La Bahia project design.

The public hearing was opened.

- Demolition by neglect
- Remaining historic integrity of the site if project is approved
- Interpretive display of the La Bahia

- R. Barker moved and G. Schwartz seconded to recommend that the City Council approve the Historic Demolition Permit. The motion was approved 4/2/1; with R. Barker, G. Schwartz, F. Miller and I. Blackwood voting YES; J. Steen and A. Meyer voting NO; D. Hooks absent.
- 3) A. Meyer moved and R. Barker seconded, to recommend that the City Council approve the Historic Alteration Permit with conditions to utilize wood windows on the historic "bell tower building" and to also add a public interpretive display of the La Bahia within the new hotel. The motion was approved 6/0/1; with Commissioner(s) A. Meyer, G. Schwartz, R. Barker, I. Blackwood, F. Miller and J. Steen voting YES; D. Hooks absent.
- 4) A. Meyer moved and R. Barker seconded to recommend that the City Council approve the deletion of all the buildings from the Historic Building Survey, with the exception of the historic "bell tower" building. The motion was approved 5/1/1; with F. Miller, I. Blackwood, G. Schwartz, R. Barker, A. Meyer voting YES; J. Steen voting NO; D. Hooks absent.
