TOPIC: New Year’s Eve Safety Enhancement Zone – Street Closures & No Parking Zones

INFORMATION:

City of Santa Cruz New Year’s Eve – Safety Enhancement Zone and Road Closures

The Santa Cruz Police Department will be deploying all available officers to ensure a safe environment for New Year’s Eve 2017. To encourage respectful behavior, the Santa Cruz Police Department has enacted a Safety Enhancement Zone designation in the downtown corridor. We will have additional officers on patrol throughout downtown as well as the remainder of the city.

The Safety Enhancement Zone will begin at 5:00 PM on December 31st and end at 5:00 AM on January 1st. The Safety Enhancement Zone allows for a “Triple Fine” to be levied on certain Municipal Code violations, such as possession of alcoholic beverages in public and other behavior related Ordinances.




SAFETY ENHANCEMENT ZONE:

TRIPLE FINE AREA

EFFECTIVE:

5:00 p.m. Saturday, December 31st to 5:00 a.m. Sunday, January 1st

From 5:00 p.m. Saturday, December 31st to 5:00 a.m. on Sunday, January 1st, certain violations of the Santa Cruz Municipal Code (SCMC) will be subject to triple fines. With court costs, you could end up paying:



- Open Container/Consumption of Alcohol Beverages in Public Places = \$480
 - Urinating or Defecating in Public = \$576
 - Littering = \$288
 - Graffiti = \$576
 - Trespassing = \$576
 - Defacing Sidewalks = \$576
 - Discharge of Firearms = \$1,440
 - Noise Control = \$576
 - Abuse or Mutilation of Trees, Plants, and Lawns = \$1,056
 - Trespassing on Public Transit Facilities = \$480
 - Traffic Regulation Disobedience = \$192-\$960
 - Traffic Control Device Disobedience = \$288
 - Improper Vehicle Parking, Standing, and Stopping = \$576
- ... along with any other violations of SCMC Chapters 6.12, 6.75, 9.12, 9.20, 9.28, 9.36, 9.50, 9.60, 9.62, 10.12, 10.16, and 10.40

En efecto a las 5:00 p.m. Sábado, 31 de Diciembre hasta las 5:00 a.m., Domingo, 1 de Enero

Comenzando a las 5:00 p.m. Sábado, 31 de Diciembre e hasta las 5:00 a.m., Domingo, 1 de Enero, ciertas violaciones del Código Municipal de Santa Cruz (SCMC) estarán sujetas a multas triples. Con los costos de corte, usted pudiera terminar pagando:

- Tirar Basura en Áreas Publicas = \$288
 - Graffiti = \$576
 - Traspasar = \$576
 - Daño a la Acera = \$576
 - Disparar Armas de Fuego = \$1,440
 - Control de Ruido = \$576
 - Orinar en Áreas Publicas = \$576
 - Recipiente Abierto/Consumo de Bebidas Alcohólicas en Areas Publicas = \$480
 - Traspasar Instalaciones de Transito Publico = \$480
 - Desobediencia a los Aparatos de Control de Trafico = \$288
 - Estacionamiento o Detenimiento Inapropiado de Vehiculos = \$576
 - Abuso o Mutilación de Árboles, Plantas, y/o Césped = \$1,056
 - Desobediencia a las Regulaciones De Trafico = \$192-\$960
