## 3. Election of Officers for 2017\*

Recommendation: That the Downtown Commission elect a Chair and Vice Chair for 2017. Background: The term of office is one year. Both Davis and Cube have filled the two-year term limit as Commission officers.

Commissioner Farrell nominated Commissioner Coonerty Protti for Chair. Commissioner Hamilton nominated Commissioner Singleton for Vice Chair.

Commissioner Farrell moved, seconded by Commissioner Coonerty Protti to close the nominations for both positions.

Motion passed: Ayes: Chair Davis; Commissioners: Farrell, Coonerty Protti, Singleton, Hamilton, and Prindle. Noes: None. Absent: Vice Chair Cube. Disqualified: None.

Chair Davis informed the Commissioners that they could elect the nominated offices by roll call or by voice vote. Members opted to do a voice vote.

# 4. Taxi Stands Downtown\*, Casey Hemard, Principal Management Analyst, City Manager's Office

Recommendation: Motion to recommend that the City Council approve a program to establish taxi stands in Downtown locations between the hours of 8:00 p.m. and 2:00 a.m. within established guidelines per Municipal Code 10.44.080.

Background and review: Casey Hemard informed the Commission that after her presentation at the December 2016 Downtown Commission meeting, this item was presented to City Council on January 10, 2017. The taxicab industry is subject to various regulations in the City, e.g., background checks, fingerprinting, drug and alcohol tests. Transportation network companies (TNC), such as Uber, are not subject to these regulations at this time.

Chair Coonerty Protti opened the public comment period.

## **Speaking to the Issue from the Floor**

• Chip, Downtown Association, voiced concern with the proposed hours of operation, that the 8:00 p.m. start time seems too early, whereas 10:00 p.m. is more reasonable. Also, the Downtown Association members need more information.

• Sharon Sweeney, Deluxe Cab, gave some historical background about the City's taxicab permitting process: background checks, drug and alcohol checks, etc. She also noted that loading zones normally are not taken up at night by visitor parking.

- Patrice Boyle. a downtown business owner, would like to see Uber be more active in Santa Cruz.
- Craig Hyder, is a former cab driver and is now an Uber driver and independent operator. Taxi stands are important so people will know where to find a taxi. Local taxis are subject to the City's restrictions (background checks, etc.), while Uber is not. This makes the taxis less competitive.

Chair Coonerty Protti closed the public comment period.

The two drivers were invited back to the podium to respond to questions from the Commissioners.

- Sharon Sweeney suggested turning loading zones to taxi stands later than 8:00 p.m. She said that this would be the most cost-effective for the City at this time; and to use the loading zone locations rather than the fire hydrant locations.
- Craig Hyder also said that a later start time for the stands is better. He noted that the taxi stand has to be located right where the bar crowd comes out. This helps keep everyone safer from drunk-driving incidents.

Vice Chair Singleton moved, seconded by Commissioner Farrell to approve an amended recommendation as follows: To recommend that the City Council approve a program to establish taxi stands in Downtown locations at 915 Cedar and 1132 Pacific and the motorcycle parking spaces on Pacific in front of the Metro, between the hours of 9:00 p.m. and 2:00 a.m. within established guidelines per Municipal Code 10.44.080.

Motion passed: Ayes: Chair Coonerty Protti, Vice Chair Singleton; Commissioners Davis, Farrell, Hamilton, and Prindle. Noes: None. Absent: ,Commissioner Cube. Disqualified: None.

# 5. Downtown Bike Lockers\*, Amelia Conlen, Transportation Coordinator

Recommendation: Accept results of the Downtown Santa Cruz Bike Locker Survey and provide input on recommendations for downtown bike locker locations and replacement strategy.

Amelia Conlen gave a presentation regarding an overview and background of the Downtown Bike Lockers. Of a total of 112 lockers in the City, 14 are out of service. Untilization of the lockers is seasonal. The most frequently used lockers are at the Metro terminal. Amelia also discussed challenges for this program. The agenda report gives more detailed information about the research and findings.

Chair Coonerty Protti opened the public comment period.

• Warren West suggested installing stackable bike lockers.
