Approval of Minutes

1. Arts Commission Action Minute from January 11, 2017

Commissioner Lock motioned for approval as written. Garcia seconded. Motion passed unanimously.

General Business

- Cardboard boat event presentation from community member Liz Kroft
 Commissioner Williamson made a motion to partner on the boat races pending
 logistics and permits allow. Commissioner Leong seconded it. Motion passed
 unanimously.
- 2. Dance Week Sponsorship (in order to waive City fees)

Commissioner Lock made a motion to sponsor Dance Week as the Commission has in the past. Commissioner Garcia seconded it. Motion passed unanimously.

- 3. <u>Wastewater walk presentation- presentation by Commissioner Bennett Williamson</u>
 Commissioner Williamson made a motion to partner with FICTILUS on a Waste
 Water Walk pending logistics and permits. Commissioner Garcia seconded it. Motion
 passed unanimously.
- 4. MAH mural matching grant request of \$30,000

Commissioner Lock made a motion to sponsor the mural with a \$30,000 contribution. Commissioner Williamson seconded it. Motion passed unanimously, noting that Commissioner Garcia recused herself for the discussion.

5. Public Hearing on Deaccessioning of two works of art as follow:

Hearing on the Deaccessioning of "Moonlight Dance" Mural at Scope Park:

Staff provided a short presentation and appended all written and verbal testimony received regarding the matter. The staff presentation highlighted the Commission's mission, vision and values as well as adopted policies which outlines criteria that may trigger the decision to deaccession a piece of public art.

The City's Mural Policy identifies the typical lifespan of a mural as 10 years.

Arts Commissioners spoke of the need to keep the City's public art collection fresh and offer opportunities to new artists. A local mural artist in attendance noted that he would 'throw his hat in the ring' once a call was posted and he thanked Mr. Bartzcak for graciously sanctioning something new.

The original artist, Peter Bartczak, read a letter blessing the placement of a new mural on site. See attached.

The Commission talked with the artist about some kind of party or celebration honoring the mural.

<u>Decision</u>: Commissioner Leong made a motion to deaccession Moonlight Dance and set a theme of "inclusivity" for the next mural - in honor of Bartczak's mural and his intention of inclusion.

Guardian Sculpture on West Cliff:

Staff gave a presentation that highlighted the Commission's mission, vision and values as well as adopted policies which outline criteria that may trigger the decision to deaccession a piece of public art. Staff appended all written and verbal testimony received regarding the matter.

Staff reported that the primary reason we considered *Guardian* for deaccessioning is her deteriorated condition – including pitting, a rusted hole, and cracks and fading to the acrylic. While *Guardian* has been much loved since its installation in 1986, it has taken a beating in the marine environment.

Six members of the public attended and spoke in favor or conserving/repairing the sculpture instead of removing it.

Six residents attended to say *Guardian* was iconic – and was worth saving. One resident offered to help offset the cost of repairs through in-kind donations. Another resident, a sculptor himself, contended that the *Guardian* had become more than just a piece of art but had become a *place* – noting that even wedding ceremonies had been held on site. "The piece has a spiritual energy and reflects our common humanity," he said.

One resident in attendance argued that he didn't believe the sculpture was allowed under the coastal overly zone regulations—adopted around the same time that the sculpture was installed. He said that he would appeal any decision to replicate the artwork or replace it was something new, possibly taking the issue to the Coastal Commission – a body that has traditionally been conservative in allowing structures along the coastline. The Arts Commission discussed the need to keep the collection fresh and open opportunities to new artists. However the possible appeal to the Costal Commission along with the fact that the original artist had submitted a draft proposal outlining repairs including the donation of his time let to a decision to conserve the work of art.

<u>Decision:</u> Commissioner Williamson made a motion to "Commission the original artist to conserve the Guardian sculpture, keeping the repairs below 50% of the structure, and provided that the artist signs a VARA/CAPA waiver." The motion was seconded by Commissioner Lock. The motion passed unanimously.
