**TOPIC:** Halloween Safety Enhancement Zone - Street Closures – and No Parking

---

### **INFORMATION:**

The Santa Cruz Police Department has enacted a Safety Enhancement Zone designation in the downtown corridor for Halloween 2018. The Safety Enhancement Zone begins on Wednesday, October 31st at 12:01 AM and runs through Thursday, November 1st at noon.

The Safety Enhancement Zone includes TRIPLE FINES for certain Municipal Code violations committed in the zone during the designated times. Examples of fines included on the attached flyer. In addition to the Triple Fines, the Safety Enhancement Zone will also dictate road closures and No Parking zones. Road closures and No Parking locations and times included on the following pages.

Annually, Halloween draws large crowds to the downtown during the evening and late night. The police department will utilize over 100 uniformed police officers from the Santa Cruz Police Department and neighboring agencies to staff the event. Officers will be using a proactive strategy to minimize problems and reduce the opportunity for alcohol-fueled problems and inappropriate behavior throughout the night.

Last year the police department responded to 342 calls for service, made 18 arrests and issued 42 citations during the Halloween evening.

In addition to the additional officers, there will be increased lighting and portable restrooms throughout the downtown corridor.

No Parking/Tow Away zone from 10:00 a.m. October 31<sup>st</sup> to 10:00 a.m. November 1<sup>st</sup> on the following streets:

- Pacific Avenue between Laurel Street and Water Street.
- Cooper Street between Pacific Avenue and Front Street.
- Cathcart Street between Cedar and Pacific Avenue.
- Soquel Avenue between Pacific Avenue and Frazier Louis Lane.

No Parking/Tow Away zone from 5:00 p.m. October 31<sup>st</sup> to 3:00 a.m. November 1<sup>st</sup>, on the following streets:

- Front Street between Soquel Avenue and Laurel Street.
- River Street between South River Street and Front Street
- Front Street between River Street and Soquel Avenue
- Front Street between Water Street and River Street.

No Parking/Tow Away zone from 5:00 p.m. October 31<sup>st</sup> to 3:00 a.m. November 1<sup>st</sup>, on the following streets:

- Locust Street between Pacific Avenue and Cedar Street.
- Walnut Avenue between Pacific Avenue and Cedar Street Parking Garage.
- Cathcart Street between Pacific Avenue and Front Street.
- Church Street between Pacific Avenue and Double Decker Parking Garage

Temporary road closures from 5:00 p.m. October 31<sup>st</sup> to 03:00 a.m. November 1<sup>st</sup>, on the following streets:

- Walnut Avenue between Pacific Avenue and Cedar Street.
- Maple Street between Pacific Avenue and Cedar Street.
- Locust Street between Pacific Avenue and Cedar Street.
- Soquel Avenue between Pacific Avenue and Front Street.
- Front Street between Soquel Avenue and Laurel Street.
- Front Street between Water Street and River Street.
- Church Street between Pacific Avenue and Double Decker Parking Garage.

Temporary road closures from 10:00 a.m. October 31<sup>st</sup> to 10:00 a.m. November 1<sup>st</sup>, on the following streets:

- Pacific Avenue between Laurel Street and Water Street.
- Cathcart Street between Cedar Street and Front Street.
- Cooper Street between Pacific Avenue and Front Street.

- Elm Street between Pacific Avenue and Cedar Street.

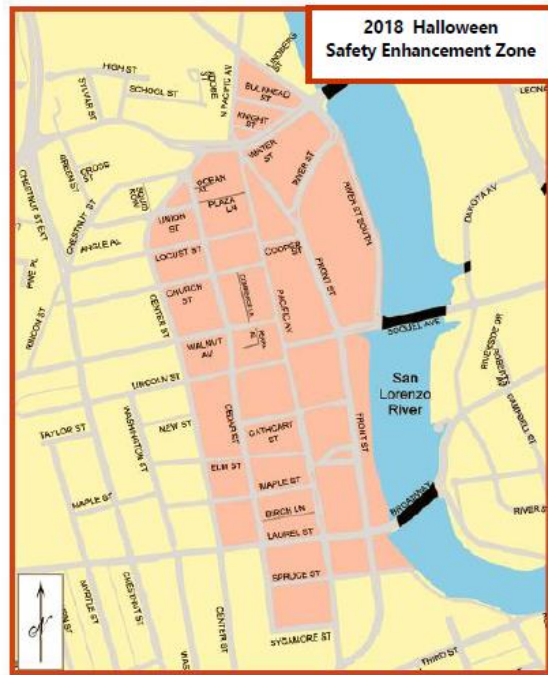

# SAFETY ENHANCEMENT ZONE: TRIPLE FINE AREA

EFFECTIVE:

12:01 a.m. Wednesday, October 31<sup>st</sup> to Noon on Thursday, November 1<sup>st</sup>

From 12:01 a.m. on October 31<sup>th</sup> to 12:00 p.m. noon on November 1<sup>st</sup>, certain violations of the Santa Cruz Municipal Code (SCMC) will be subject to triple fines. With court costs, you could end up paying:



- Open Container/Consumption of Alcohol Beverages in Public Places = \$480
  - Urinating or Defecating in Public = \$576
  - Littering = \$288
  - Graffiti = \$576
  - Trespassing = \$576
  - Defacing Sidewalks = \$576
  - Discharge of Firearms = \$1,440
  - Noise Control = \$576
  - Abuse or Mutilation of Trees, Plants, and Lawns = \$1,056
  - Trespassing on Public Transit Facilities = \$480
  - Traffic Regulation Disobedience = \$192–\$960
  - Traffic Control Device Disobedience = \$288
  - Improper Vehicle Parking, Standing, and Stopping = \$576
- ...along with any other violations of SCMC Chapters 6.12, 6.75, 9.12, 9.20, 9.28, 9.36, 9.50, 9.60, 9.62, 10.12, 10.16, and 10.40
