<p>NARRATIVE:</p> <p>On 10/11/2016, at approximately 2120 hrs, I was dispatched to the location of [REDACTED] Chace Street for report of a 5150 subject. The RP, [REDACTED] ARLT, advised that his son was acting erratic and manic. Upon arrival, I recognized the subject as Sean ARLT, whom I contacted yesterday for a 5150 evaluation and also completed a missing person's report for him later in the evening. S. ARLT lives at his parent's house located at [REDACTED] Plateau Avenue, which is the location where I contacted him yesterday, arriving today at [REDACTED] Chace Street to a family friend's house. PO BADEO (who was dispatched to the location with me) and I approached S. ARLT in an attempt to talk him.</p> <p>J. ARLT and several other family members were standing with S. ARLT on the sidewalk of Chace Street/Getchell Street with S. ARLT holding writing pens, one in each hand, in a stabbing-like position. While doing this he had a blank stare, continuously stating, "These are my two keys to heaven." All conversation with S. ARLT seemed to not register with him.</p> <p>J. ARLT proceeded to tell S. ARLT to hand over the pens to me. S. ARLT slowly handed the pen that he was holding on his right hand to J. ARLT, who then handed to me. I placed the pen on the hood of PO BADEO's patrol vehicle.</p> <p>After a few moments, S. ARLT attempted to walk away. At this time he was only holding one of the writing pens but still holding it in a stabbing-like position. From a safe distance I attempted to block S. ARLT's movement. S. ARLT continued to approach me holding the pen and a stabbing-like position. I gave clear and concise orders to S. ARLT to stop walking towards me and to drop the pen. All commands for him to stop were ignored by S. ARLT until I displayed my Taser in an attempt to stop his movement. S. ARLT stopped but stated while he was standing, "This is my key to heaven; I want to go to heaven." All of this was said while he continued to hold the pen in a stabbing-like position.</p> <p>I noticed PO BADEO was in my backdrop behind S. ARLT so I could not deploy my Taser. I holstered my Taser as PO BADEO and I attempted to take control of S. ARLT. S. ARLT resisted both me and PO BADEO to where we had to take him down to the ground. S. ARLT</p>

<p>was uncontrollable on the ground and was resisting both myself and PO BADEO. All control holds were unsuccessful and S. ARLT would not let go of the pen that was still in his hand.</p> <p>I unholstered my Taser but was unable to use the drive stun mode due to the resisting of S. ARLT. Instead I opted to deploy but prior to deploying, I gave a Taser deployment warning by stating "Taser" "Taser" "Taser" and proceeded to deploy my department issued the Taser (Serial number X2900323N) into the buttocks area of S. ARLT. The Taser probes had no effect on ARLT. I deployed a second cartridge again into S. ARLT's buttock area. The second cartridge Taser probes had no effect on S. ARLT either. S. ARLT still resisted me and PO BADEO. Due to the continuance of resistance from S. ARLT, I deployed three cycles using the ARC button again to no effect. PO BADEO attempted to place a Carotid Restraint Hold on S. ARLT. S. ARLT immediately defended the Carotid Restraint Hold by tucking his chin down and turning his head towards the right side. PO BADEO abandoned the Carotid Restraint Hold since S. ARLT was defending it properly.</p> <p>PO BADEO and I decided that it will be safest if we just held S. ARLT down on the ground and obstruct his movements until other officers arrived on scene.</p> <p>Officers arrived and assisted to place S. ARLT in shackles and handcuffs. Since S. ARLT was exposed to the Taser deployment, SCFD/AMR was requested to the scene by Sgt. AZUA to medically evaluate S. ARLT. S. ARLT at the time was still very irate and resisting so he was placed in the Wrap Safety Restraint Device. S. ARLT was eventually transported via ambulance to Dominican Hospital for medical treatment.</p> <p>S. ARLT's family was interviewed by other officers at the scene regarding the details of this incident.</p> <p>PO GUNTER, PO BURRELL and PO RODRIGUEZ stayed with S. ARLT at the hospital. While at the scene, PO BADEO collected several afid tags from Taser cartridges I deployed and later booked them into property for evidentiary purposes.</p> <p>I completed the 5150 W&I 72 Hour Hold Form for S. ARLT and delivered it to Dominican</p>

Supervisor's Report for 148(a) PC Investigation:

SYNOPSIS:

refusing to take his medication. Mr. Arlt had been reported missing person last night (10/10/2016) under case 16S-08532. Mr. Arlt came home earlier this morning and was removed from MUPS.

PO Trindade was overheard stating on the radio "drop the pen." At this time, I notified dispatch that all incoming units were clear for "code 3". I made this decision because I could hear the urgency in PO Trindade's voice. I also know from my training and experience working downtown that people who suffer from mental health problems can become violent and will attack another person without any notice.

Upon arriving, I saw several Officers at the corner of Chase and Getchell attempting to hold down Mr. Arlt. Mr. Arlt was breathing heavy and would not comply with our commands. I asked Mr. Arlt to calm down because we were there to help him. We attempted to place Mr. Arlt into a department approved Wrap for his safety; however, he exhibited abnormal strength. We tried several times to place Mr. Arlt into the Wrap, but we became tired and decided to hold him down until we could catch our breaths. We then decided to call for Fire and AMR to our location. Our plan was to have AMR give Mr. Arlt a tranquilizer to calm him down. Mr. Arlt began to move around again at which point we successfully placed him into the approved Wrap. Fire and AMR arrived and provided medical treatment to Mr. Arlt before he was transported to Dominican Hospital.

I then spoke with PO Trindade who said that he encountered Mr. Arlt at [redacted] Chace Street holding a pen in a stabbing position. PO Trindade stated that Mr. Arlt said that the pen he was holding were the keys to heaven. PO Trindade said he feared that Mr. Arlt was going to harm him and PO Badeo if they did not take away the pen. PO Trindade said that Mr. Arlt walked towards him with the pen still in the stabbing position which caused him to deploy his department issued Tazer for officer safety reasons. PO Trindade said that he stunned Mr. Arlt several times; however, it had not affected him. PO Trindade said that he bruised his left kneecap but did not require medical attention. Based on the fact that Mr. Arlt was not medically cleared and suffered from mental health problems, I decided not to book him immediately into the Santa Cruz County Jail for the 148(a)PC until he was medically released from the Tele- Care facility. The Notifications to be Provide to Law Enforcement Agency was checked. PO Trindade also called the Tele-Care staff and informed them of the situation. PO Trindade also placed onto Roll Call the Santa Cruz County Field Booking form and the Probable Cause form.

I read Mr. Arlt his Miranda Warning verbatim of my department issued card. Mr. Arlt became upset and started to clench his fist that were still handcuff. Mr. Arlt mood swing became violent at which point I stopped my attempts to interview him.

I arrived and saw PO Trindade and PO Badeo on the north west corner of the intersection. I saw that both officers were holding down a subject, later identified as Sean Arlt. I ran to the officers and they advised Arlt was still holding the pen. I was able to see Arlt clutching a plastic pen in his left hand. Arlt was grasping the pen in his closed left fist. I reached in and attempted to remove the pen but Arlt blocked me with his right hand. I asked PO Trindade and PO Badeo to control his right hand and I was able to remove the pen from his left hand. Arlt was tensing his muscles and resisting both officers as they attempted to detain him. I attempted to control Arlt's legs as PO Badeo and PO Trindade tried to detain Arlt in handcuffs. Arlt tensed his leg muscles and twisted left and right. PO Winston arrived and retrieved shackles from a nearby patrol vehicle. It took several minutes to restrain Arlt in handcuffs and leg shackles. During the time Arlt resisted our efforts by twisting left and right and tensing his muscles. After considerable effort we were able to detain Arlt in

On 10/11/16, at approximately 2110 hours, I responded Code 3 to cover PO Trindade #142 in the area of Chace St. PO Trindade was making contact with a subject for a 5150 welfare check and I heard PO Trindade advise that the subject was holding a pen and refusing to drop the weapon.

Myself and PO Burruel #191 responded from the PD with a 40 mm less lethal impact weapon. When I arrived on scene I saw that multiple officers were holding the subject, SEAN Arlt on the ground. I assisted in securing him in leg shackles and could see that the tazer had been deployed. SEAN was displaying abnormally high strength for his size and it took multiple officers to try to control him.

There were 3 people standing in front of Chace St watching the incident and I contacted the group to locate witnesses to obtain statements. I contacted Arlt who was SEAN'S father and the reporting party.

I activated my department issued audio recorder to record statement. Later I downloaded the audio recording to the Q:Drive as evidence. The following is a synopsis of statement: son, SEAN had been diagnosed with a mood disorder

and was possibly bi-polar. He was prescribed 250 mg of Welbutrin but also smoked marijuana and drank alcohol. SEAN had been at their house acting strangely and told [REDACTED] that he had not slept in 4 days. SEAN left the house and [REDACTED] received a phone call from [REDACTED] that SEAN had just ran into their house and was acting very weird and bleeding. [REDACTED] drove over there ([REDACTED] Chace St) and called 911. When he arrived [REDACTED] saw SEAN standing very still in the driveway not wearing a shirt or shoes. SEAN was not talking to them and not acting aggressive. When the police arrived on scene [REDACTED] walked over to talk to them and SEAN followed and was holding two pens. SEAN did not hold the pens as weapons but said that they were the "keys to heaven." [REDACTED] understood that the pens could be used as a weapon. When the two officers approached SEAN was not paying attention to them and did not respond to questions or commands. SEAN slowly began to walk away as the officers tried to get him to drop the pens. They asked multiple times and said that they did not want to hurt SEAN. [REDACTED] stated that he saw the officers were in full uniform and in marked patrol vehicles but stated that SEAN was in his own world. PO Trindade was addressing SEAN as PO Badeo came up behind SEAN and gently took SEAN to the ground. The two officers were then on the ground trying to get the pens from SEAN'S hands. They asked multiple times for the pens. The officers were not excessive and never punched SEAN. The officers warned SEAN that they would taze him and he did not comply so they tazed him in the leg approximately three times. At that point multiple officers responded and assisted in restraining SEAN on the ground. [REDACTED] commented that it is very difficult to control someone having a psychotic break and did not know what else the officers could have done. [REDACTED] stated that anyone in a normal state of mind would have complied with their commands

NARRATIVE

On 10/12/2016 at approximately 2120 hours, I was dispatched as a cover officer to Chace St. for a report of a welfare check on a 5150 W&I male subject. This subject was later identified as Sean ARLT. The reporting party was ARLTS father named [REDACTED] reported that his son ARLT is manic with a mood disorder and was refusing to take his prescribed medication. ARLT resides at his parents house at Plateau Ave. and decided to go to Chace St. to a family friends house. It should be noted that ARLT was listed as a missing person last night (10/10/2016) under case 16S-08532. ARLT came home earlier this morning and was removed from MUPS.

Upon our arrival, I and P.O. R. Trindade #142 were met by ARLTS father [REDACTED] and several other family members at the northwest corner of Chace St. and Getchell St. At the time, I noted that ARLT was holding two pens on his person, one on each hand. I noted that ARLT seemed distant and he had a thousand yard stare. ARLT was holding the pens pointing towards his chest area and said something to the effect of the pens being the key to heaven and that he wanted to go to heaven. During this time, ARLT was standing on the northwest sidewalk of Chace St. and Getchell St. to the right of ARLT is his father, [REDACTED] I and P.O. Trindade was standing in front of ARLT and his father. [REDACTED] proceeded to tell ARLT to hand him over the pens which ARLT started to do so. ARLT slowly handed the pen

that he was holding on his right hand to [REDACTED] which [REDACTED] handed to P.O. Trindade. P.O. Trindade had placed the pen that was given to him on the hood of my patrol vehicle, which was next to us.

[REDACTED] at the time had asked ARLT to hand over the other pen, which was on his left hand but he refused. ARLT then proceeded to walk eastbound on Chace St. towards Getchell St. As ARLT was walking, he kept saying that he wanted to go to heaven. It should be noted that the intersection of Chace St. and Getchell St. is not a well-lit intersection and there could be a potential for ARLT to get hit by a speeding vehicle if he proceeds to walk onto the intersection without paying attention.

During this time, P.O. Trindade walk passed ARLT to try and prevent him from reaching the intersection. ARLT was not listening to P.O. Trindades verbal commands for him to stay still and preferably on the sidewalk area. P.O. Trindade provided ARLT clear and concise direction, but he would not comply. ARLT continued to hold the pen on his left hand in a stabbing motion and was walking towards P.O. Trindades direction. At the time, I stayed towards the right side of ARLT and maintained a safe distance in case he directs his attention towards me with his pen. P.O. Trindade continued to provide ARLT clear and concise directions, but he would listen. During this time, I had the time to activate my department issued audio recorder and was able to capture approximately a minute of this incident.

ARLT proceeded to ignore P.O. Trindade's commands and at one point briefly tried to turn and walk away. I noted that ARLTS fist was clenched so hard and was holding onto the pen on his left hand with all his strength. P.O. Trindade had his department-issued Taser displayed. (Please refer to P.O. Trindades CR-1 report for additional details). During this time, ARLT stood still in the middle of the sidewalk which provided us with enough time to close the distance towards him and was able to hold him on each side of his arms. Upon closing the gap with ARLT, I immediately held his right arm using both of my hands. P.O. Trindade held ARLTS left arm and left hand. I and P.O. Trindade proceeded to tackle him to

As I was looking at ARLTS face while he was on the ground, I noted that he was clenching his jaw and his face appeared very angry.</p> <p>During this time, to prevent ARLT from escaping our grasp and to prevent him from further hurting himself or us, I decided to stabilize his position by placing my right knee around his solar plexus area. I put enough pressure on ARLTS body so that he could not move around but he continued to do so. While this incident was unfolding quickly, I kept telling ARLT to stop resisting and for him to calm down and that we were there to help him. During this time, I did not deliver any other distraction blows beside my right knee into his solar plexus area.</p> <p>ARLT continued to resist even after all our efforts of talking him down and trying to defuse the situation. At one point, ARLT was able to start moving me away from being on top of him by shifting his body left to right. As my control holds against ARLT was unsuccessful, P.O. Trindade started to deploy his department issued Taser on ARLT. (Please refer to P.O. Trindades CR-1 report for the Taser deployment). P.O. Trindade deployed his Taser on ARLT several times, but it did not appear to have any effect on him.</p> <p>At this time, I tried to maintain the top position against ARLT while trying to take the pen from his left hand. I had placed my left hand over ARLTS left hand in my attempt to pry the pen away from his grasp. During this time, ARLT had placed his left hand on his chest area once again and held onto my left hand using his right hand to prevent me from prying the pen from his grasp. I told P.O. Trindade that ARLT has a death grip on the pen and that I was unsuccessful from removing it from him. P.O. Trindade had continued to deploy his Taser since ARLT is still armed with a pen and had the potential to use it against us. While I and P.O. Trindade was grappling against ARLT on the ground; I was very careful not to be stabbed with the pen.</p>

NARRATIVE

In my attempt to dislodge the pen from ARLTS left hand, I proceeded to apply more pressure on ARLTS upper chest area by placing my left knee on top of it. This move appeared to have no effect on ARLT as well. ARLT proceeded to turn his body towards his left area and was able to turn his back on me. During this time, I was able to move ARLTS left hand away from his chest area and into the pavement. At the time, we already had exhausted all the reasonable force option against ARLT, but none of them seemed to have an effect on him. My main goal in this incident was to effectively and safely subdue ARLT as quickly as possible to prevent him from further hurting himself us. As ARLT had his back turn against me, I saw an opportunity to place him on a carotid restraint hold. It should be noted that a carotid restraint is very effective in controlling subjects experiencing an agitated-chaotic event. The carotid restraint hold generates a painless unconscious state in 7 to 10 seconds. The ability to quickly and efficiently render an agitated-chaotic subject unconscious significantly minimizes the risk of injuries to officers and to the suspects that often results from prolonged struggles.

At the time, I then placed my right arm under ARLTS neck and chin area. ARLT immediately defended the carotid restraint hold that I was trying to initiate by tucking his chin down and turning his head towards the right side. At the time, I did not continue to apply the carotid restraint against ARLT since it would not have been effective since ARLT was defending it properly.

During this time, I decided that it will be safest if I just hold ARLT down on the ground and stabilize his position until several other officers arrived at the scene. P.O. J. Auldrige #125 arrived shortly and was able to remove the pen from ARLTS left hand. I took a minimum of five officers to be able to get ARLT properly restrained. P.O. B. Burrell #191 was able to place ARLT in a WRAP (Safety Device) to prevent him from further hurting himself. ARLT was transported to Dominican E.R. for medical treatment since he was exposed to Taser deployment.

ARLTS family was interviewed by other officers at the scene regarding the details of this

On the listed date and time I was working patrol for SCPD. I was wearing a SCPD uniform and I was riding passenger with PO Burnham who was driving patrol car 154. We responded with other officers to Chace St as PO Trindade advised over the radio that he was with a male, later identified as Sean ARLT, that was refusing to drop a pen that was in his hand. Please refer to PO Trindade's report for further information about the call for service he was dispatched to involving ARLT and what led up to his radio traffic involving ARLT refusing to drop a pen.

I arrived and assisted with the detention of ARLT. When I arrived, ARLT had one wrist handcuffed and I assisted in restraining his other wrist in the other handcuff. I noticed that ARLT's body was very tense and rigid and was not complying with anything the officers restraining him were telling him to do. ARLT was not attempting to strike, kick or punch any of the officers, ARLT simply appeared very aggitated and did not want to be restrained. There were about four other officers working together to restrain ARLT and talk with him to get him to calm down. ARLT was in a seated position on the sidewalk with a couple officers helping to restrain his leg movement and a couple officers next to both of his shoulders to help restrain his upper torso movement. Nothing the officers were doing to restrain ARLT was restricting ARLT's ability to recover or breath in any way. Everything officers were

doing to restrain ARLT was in an attempt to prevent ARLT from being a danger to himself or someone else.

I quickly learned based on my observations, training and experience and what little I knew about the call for service that ARLT was suffering from some type of mental illness. ARLT was not logical in his actions. Despite being restrained in handcuffs, ARLT fought with all his might against the handcuffs and at one point tried to move his handcuffs under his buttocks and under his legs, to the front of his body. ARLT did not say much, if anything and just continued to make attempts at releasing himself from the restraint of the handcuffs and the leg shackles around his ankles. Despite being alert and oriented, ARLT was non-responsive to officers as they attempted to speak and reason with ARLT.

Shortly after I arrived, PO Gunter took the lead and began communicating to other officers working to restrain ARLT. PO Gunter encouraged limited communication from other officers in attempt to help ARLT calm down. PO Gunter used a very calm and relaxing tone of voice as he spoke with ARLT. ARLT stopped resisting so violently and appeared to be calming down. I worked with PO Gunter to apply the Wrap, a restraining device specifically designed to assist in the restraint of violently resisting people. I applied the Wrap to ARLT and ensured all the buckles and straps were secured and of the proper tightness. I applied the entire Wrap device to ARLT's body. The Wrap was very effective in preventing ARLT from being a danger to himself or others.

I worked with other officers to lift ARLT onto the paramedic gurney. ARLT was placed into the back of the ambulance and I rode in the ambulance with ARLT and the paramedics to Dominican Hospital. PO Rodriguez drove immediately behind us all the way to the hospital. I stood by ARLT as he was rolled on the gurney into a room at the hospital. I stood by with PO Gunter in case ARLT needed to be unhandcuffed or for any reason our assistance was needed.

I was relieved by Sgt. Azua and PO Gunter remained at the hospital with ARLT.

On 10-11-16 at approximately 2110 hours, I responded Code 3 in vehicle 157 to the area of Chace and Getchell Street in order to cover PO TRINDADE. PO TRINDADE had been conducting a welfare check on a subject with mental health issues. I responded from the Police Department.

Upon arrival on scene I observed PO TRINDADE and PO BADEO on the ground on the North West corner of the intersection. They were attempted to detain Sean ARLT for a mental health evaluation. As I exited my patrol vehicle I could hear PO TRINDADE telling ARLT to drop the pen. I ran to their location and could see ARLT's mother and father on the sidewalk 5-10 feet West of their location. I also noted that PO TRINDADE's taser was on the ground and the wires from the taser were on the ground an indication that they had been deployed.

I was able to secure ARLT's left hand. As I maintained a grip on his hand I tried to talk to him to calm him down. I tried 5-10 times to initiate a conversation with him. I noticed that the veins and muscles in his neck were rigid and he continued to try to straighten his body. ARLT was unresponsive to any verbal commands given. After 1-2 minutes of struggle we were able to place handcuffs on ARLT. After he was placed into handcuffs he continued to

pull away from Officers and was able to lift Officers off of his lower body.

Additional Officers and the Sgt. arrived on scene. We used the wrap safety restraint to prevent ARLT from harming himself. As soon as ARLT was secured we had Santa Cruz Fire Department Paramedics and AMR respond Code 3 to the scene since the taser had been deployed.

Once the initial treatment of ARLT was concluded AMR transported him to Dominican Hospital. PO BURRELL road with him in the back of the ambulance. PO S.RODRIGUEZ and myself followed the ambulance to the hospital. Once at the hospital ARLT had to be administer a sedative so that he would calm down so the hospital staff could even talk with him. At around 2240 hours ARLT had finally become able to talk in sentences. He had asked to have his handcuffs taken off and for a glass of water.

ARLT was released to the care of Dominican Hospital Staff for his behavioral health evaluation.

After ARLT stopped wanting to get up PO Gunter and PO Badeo sat him up and held him as ARLT caught his breath and started to calm down. It should be noted that at no time was ARLT'S ability to breath compromised, he was just held down for his own safety.

ARLT was then placed into the "wrap" and he was fully restraint. Paramedics arrived and he was transported to Dominican ER via ambulance. It should be noted that PO Burrell rode in the back of the ambulance to provide security to the paramedics.
