NARRATIVE

On 10/10/16 at approximately 1925 hours, I was working patrol in the Live Oak area of Santa Cruz County. Deputy Brownlee and Deputy Hudson were dispatched to Dominican Hospital for a report of 32 year old male, Sean Arlt who was possibly having a psychotic break. Dispatched advised that Sean Arlt was at Dominican Hospital with his mother and Dominican Hospital Security. At 1931 hours, I heard Deputy Brownlee arrived on scene and tell dispatch that he was out with "all three" and was "code 4 at the moment". I knew I was fairly close to Dominican Hospital and attached myself to the call. At 1941 hours, I arrived on scene and found Deputy Brownlee speaking with Arlt's mother

Deputy Brownlee notified me when he arrived on scene Arlt appeared to be calm and was having a conversation with his father. Deputy Brownlee spoke to Arlt's mother but did not have enough information to detain Arlt for 5150 W&I. Arlt asked Deputy Brownlee if he could smoke and Deputy Brownlee allowed him to have a cigarette. Deputy Brownlee continued to talk to Stacey and Arlt walked away and his father, and arlt followed him. Refer to Deputy Brownlee's report for further details.

Deputy Brownlee continued to speak with while she tried to explain why she believed Arlt was a danger to himself. I stood by and listened to their conversation. Refer to Deputy Brownlee's report for further.

Deputy Hudson arrived on scene and Deputy Brownlee went over to his patrol vehicle to fill him in on our conversation with

mental health issues. I explained we needed to articulate in our reports why someone is a danger to themselves, danger to others or gravely disabled. I also mentioned that we work closely with County Mental Health and have a County Mental Health Liaison that works in our office. I gave her my business card with County Mental Health Worker James Russell's name and contact information. I told her to call him the next day and hopefully he would be able to guide her in the right direction and give her some resources to help her and her family.

After speaking with period, Deputy Brownlee, Deputy Hudson and I circulated the area around Dominican Hospital in an attempt to contact Arlt. After driving around for several minutes, I was unable to locate Arlt. Deputy Brownlee advised Deputy Hudson and me that he spoke to Arlt's father and he advised him Arlt was "capable of walking home or ordering Uber". I cleared the detail.

On 10/11/16 at approximately 1500 hours, I contacted James Russell at Sheriff's Office Headquarters and asked him it contacted him. He confirmed contacted him and they had a conversation.
