

RESOLUTION NO. NS-29,644

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA CRUZ
CONFIRMING AND APPROVING THE CANVASS OF BALLOTS AND RETURNS FOR
THE CITY OF SANTA CRUZ PRESIDENTIAL PRIMARY ELECTION HELD ON
MARCH 3, 2020 AND DECLARING THE RESULTS

WHEREAS, at its meetings on September 24, 2019, October 22, 2019, and November 26, 2019, the City Council adopted Resolution Nos. NS-29,573, NS-29,588, and NS-29,598 calling for a Presidential Primary Election in the City of Santa Cruz for the purpose of placing two measures and two recall questions on the March 3, 2020 ballot.

WHEREAS, on March 3, 2020, the election so called and ordered was held in accordance with law and the votes were counted; and

WHEREAS, the County Clerk has certified the results of the election to this Council and this Council has approved the canvass of ballots and the returns of said election.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Santa Cruz that it hereby certifies the following:

1. The Presidential Primary Election referred to above was held in the City of Santa Cruz on March 3, 2020.
2. The certified canvass of returns is set forth in Exhibit "A" and incorporated by reference.
3. Votes were cast for the question to recall Chris Krohn and Drew Glover from the office of Santa Cruz City Councilmember


