Minutes of the June 24, 2009 Regular and Special Closed Session Meeting

I. Call to Order

Chair/Councilmember Robinson called the meeting to order at 3:07 p.m. in the City Attorney's Conference Room at 333 Church Street. Councilmembers Robinson and Lane and Vice Mayor Rotkin were present. The meeting was staffed by T. Shull and W. Barry.

II. Approval of the Minutes of the April 13, 2009, October 20, 2008 and November 17, 2008 Meetings

Vice Mayor Rotkin moved to approve all three sets of minutes, noting for the record that he was absent for two of the three meetings but that he understands the minutes to be true and correct. The motion was seconded by Councilmember Lane. The motion carried unanimously.

Chair/Councilmember Robinson briefly discussed the Emergency Preparedness Forum she is organizing for October 15, 2009, the 20th anniversary of the Loma Prieta Earthquake. Chair/Councilmember Robinson stated that the educational forum would be about 1½ hours in length and consist of a panel of four to five speakers and possibly a short lecture by a local historian. The Committee discussed ideas for coordination with the Downtown Association and other activities to commemorate the anniversary. No action was taken.
