NARRATIVE

On 12/31/21 at roughly 1919 hours, I was dispatched to the Armory (301 Upper Park Rd) for a report of a suicidal subject. Dispatch advised that a subject named [REDACTED] was staying at the armory and was having suicidal thoughts. Dispatch advised that [REDACTED] was threatening to slit his wrists and was asking other guests for a knife. While I was en route to the call, I was advised by other officers that [REDACTED] had a history of being combative with officers. I arrived on scene a short time later.

When I arrived, I was advised by PO Shatto that [REDACTED] was going to be detained. Myself and other officers entered the facility and made contact with [REDACTED]. [REDACTED] was seated in a bed at the time of our contact with him. PO Shatto advised [REDACTED] that he was going to be detained, and grabbed his wrist to place him in handcuffs. I noted that [REDACTED] had a wheelchair next to his bed, and it appeared as if he was unable to walk. I moved the wheel chair over toward the bed, and other officers assisted with moving [REDACTED] into the wheelchair. I heard [REDACTED] cussing at officers, but could not understand exactly what he was saying. [REDACTED] was wheeled out to the patrol vehicle, where he refused to be put in the back seat. Several officers had to lift [REDACTED] to help get him into the patrol vehicle.

I was later advised by PO Shatto that [REDACTED] had spit on her while being put in the

wheelchair from his bed. I reviewed my Body Worn Camera of the incident. At roughly the 4 minute mark, [REDACTED] is seen turning his head toward PO Shatto as she is trying to move him to the wheelchair and spitting in the direction of her arm. The video was later downloaded onto evidence.com.

PO Shatto eventually transported [REDACTED] to the Behavioral Health Unit, and I followed. At the Behavioral Health Unit, [REDACTED] refused to get out of the patrol vehicle and had to be carried from the back of the patrol vehicle and into the intake room. Staff at the Behavioral Health Unit called for an ambulance to transport [REDACTED] to the hospital due to them not being able to accommodate a non ambulatory detainee. Myself and PO Shatto both cleared the scene prior to the ambulance arrival.

A short time later, PO Shatto was requested back at the Behavioral Health Unit to assist the ambulance crew with [REDACTED]. PO Shatto advised that while trying to help place [REDACTED] onto the ambulance gurney, [REDACTED] tried taking a swing at her. PO Shatto requested that I respond to the Behavioral Health Unit to obtain a witness statement.

I contacted [REDACTED] who advised he was a staff member at the facility. [REDACTED] provided the following statement:

[REDACTED] advised that he was standing on the side of [REDACTED] and PO Shatto was standing on the opposite side. [REDACTED] advised that he and PO Shatto were attempting to lift [REDACTED] onto the gurney. [REDACTED] advised that PO Shatto was explaining to [REDACTED] that he needed to get onto the gurney. [REDACTED] said that as they were attempting to lift [REDACTED], he took a swing at PO Shatto. [REDACTED] said that it appeared as if [REDACTED] was trying to punch PO Shatto, and would have hit her had she not moved. [REDACTED] said that PO Shatto had to move her head backward to avoid being hit. [REDACTED] advised that [REDACTED] came within inches of hitting PO Shatto. [REDACTED] said that after [REDACTED] took the swing, he and PO Shatto grabbed a hold of [REDACTED] arms and held him down. [REDACTED] said that [REDACTED] did not make any

statements prior to taking the swing, and was crying and cursing under his breath afterward. [REDACTED] stated that PO Shatto did not use any force on [REDACTED] and maintained her composure throughout the incident. [REDACTED] said they were able to get [REDACTED] onto the gurney without further incident. I asked [REDACTED] if he recognized PO Shatto as a Police Officer, and he stated he did based on her uniform.

I asked [REDACTED] if there was any video surveillance of the incident, and he stated there was. [REDACTED] advised that his manager had access to the video, and he was unable to view it. [REDACTED] advised he would request the video from his manager and forward it to my email. I will add a supplemental report when the video is obtained.

NARRATIVE

On 12/31/2021, at approximately 1919 hours, I responded to 301 Upper Park Road on the report of a suicidal subject at the Armory Shelter. The reporting party advised that a male subject, identified as [REDACTED], had made multiple suicidal statements and asked multiple residents and staff members to "slit his wrists". I was familiar with [REDACTED] from previous law enforcement contacts and knew he had a history of being uncooperative and resistant to officers. I responded from the Santa Cruz PD, arriving on scene minutes later.

Upon arrival, I activated my body worn camera and contacted [REDACTED] with multiple officers. Upon contact, [REDACTED] was sitting upright on his bed in his assigned area. It had already been determined that [REDACTED] met the criteria for a 5150W&I hold and I began to assist PO Shatto #158 with the detention. As I assisted with the detention I noted that [REDACTED] began shouting obscenities at officers. [REDACTED] refused to move into his wheelchair, which he claimed he needed. Officers assisted [REDACTED] into his wheelchair while he shouted at officers. Once in the wheel chair, I watched as [REDACTED] quickly turned his head to the right, away from me and towards PO Shatto. [REDACTED] spit towards PO Shatto and I could see saliva leave his mouth, towards PO Shatto. PO Shatto related that [REDACTED] had spit on her arm once.

Upon return to the Santa Cruz PD, I reviewed my body worn camera footage. In the footage, ██████████ can heard being verbally aggressive with officers, swearing at them and shouting. Further ██████████ could be seen turning his head and spitting towards PO Shatto.

NARRATIVE

On 12/31/2021, at 1919 hours, I responded to the National Guard Armory (301 Upper Park Road) for a report of a suicidal subject, who was identified as [REDACTED]. It should be noted that I received a similar report at 1734 hours, in which Dispatch initially advised that [REDACTED] had extensive 148 history. When I responded at 1734 hours, I had made contact with [REDACTED]. [REDACTED] advised me that [REDACTED] was being uncooperative with the intake process. During her attempt to get his information, [REDACTED] told her he wanted to slit his wrists. Upon arrival, [REDACTED] was sleeping. Based on [REDACTED] prior history with not being cooperative with law enforcement, I advised [REDACTED] that I would be not be awaking him for an evaluation. [REDACTED] advised me when I arrived the second time that [REDACTED] had been asking other residents for a knife in order to slit his wrists. Based [REDACTED] statement, I believed that [REDACTED] was a danger to himself and decided to place him on a 5150 hold. Please refer to Case Number 21S-07868 for more information regarding the 5150 hold.

I made contact with [REDACTED] and placed him in handcuffs for the detainment. [REDACTED] made several comments that he was incapable of walking. Based on this statement, other officers and I placed [REDACTED] into a wheelchair. Upon placing [REDACTED] into the wheelchair, [REDACTED] turned his head and spat on my right forearm. After [REDACTED] spat on my arm, he stated "fuck you". I believed this was an intentional act and was a violation of 243(b) PC. It should be noted that I did not immediately notify Sgt Badeo #115 regarding the incident as [REDACTED] was being placed on the 5150 hold.

[REDACTED] was wheeled out to my patrol vehicle and placed in the rear for transport to Santa Cruz BHU. It should be noted that [REDACTED] refused to stand or attempt to assist us in helping him stand while placing him in the back of the patrol vehicle. This required officers to physically lift him and place him in the back of the patrol vehicle. In the process, [REDACTED] had minor abrasions on his feet.

I transported [REDACTED] to the Santa Cruz BHU. I was advised by BHU staff that they would not be accepting him due to them not being able to accommodate for patients in a wheelchair. I coordinated with BHU staff to have [REDACTED] transported via ambulance to a more accommodating facility. I provided the 5150 hold to BHU staff and left the scene.

Shortly after leaving, Dispatch advised me that [REDACTED] was not being cooperative with BHU staff or AMR staff. I arrived back on scene and made contact with Paramedic [REDACTED] [REDACTED]. [REDACTED] stated that [REDACTED] was not being cooperative with the AMR transport. I was advised that [REDACTED] reportedly told BHU staff that he would be okay with a walker to get around the facility, despite previously stating he was unable to walk at all. I went inside with [REDACTED] and his partner to assist them with placing [REDACTED] onto the gurney for medical transport.

Upon seeing me, [REDACTED] clenched his right fist and drew it back as if he were going to punch me. [REDACTED] moved the clenched fist towards me, as if to attempt to punch me. I grabbed [REDACTED] left hand and placed him in a rear wrist lock, which forced [REDACTED] out of the chair. [REDACTED] laid across the gurney perpendicularly. [REDACTED], BHU staff, and I then placed [REDACTED] onto the gurney. [REDACTED] was placed into four point restraints and transported to Watsonville Community Hospital. Based on [REDACTED] actions, I believed that he was in violation of 241(b) PC. Sgt Badeo was notified of both the 243(b) PC and 241(b) PC incident.

Based on the fact that [REDACTED] was actively on a 5150 hold and extremely uncooperative with all parties involved, I did not believe that citing [REDACTED] out on the charges would be safe for either officers or [REDACTED]. Sgt Badeo was aware of the circumstances and recommended a warrant recommendation instead to prevent any additional interactions with [REDACTED] that would affect officer safety.

I was later contacted by Watsonville Community Hospital staff for a correction of the 5150 hold. I made the necessary corrections on the hold and provided it to PO Wilkins #175 for it to be taken to Watsonville Community Hospital.

I contacted [REDACTED] via landline for a statement regarding the incident. [REDACTED] stated [REDACTED] had been "verbally aggressive" with BHU and AMR personnel prior to my arrival. When I entered the BHU Sally Port, [REDACTED] claimed that [REDACTED] was "immediately aggressive" with me. [REDACTED] saw [REDACTED] make a fist and drew it back as if to punch me. When I asked [REDACTED] what he believed [REDACTED] intentions were, [REDACTED] stated that it "looked like a punch" and that [REDACTED] threw his hand back to punch me. The

himself. As P.O. Shatto was assisting ██████████ to a wheelchair in order to be able to move him to her patrol vehicle, ██████████ proceeded to turn and spat on P.O. Shatto's right forearm. After ██████████ was admitted to TELECARE, ██████████ needed to be transported to a hospital to better suit his needs since he was currently wheelchair-bound. ██████████ has to be transferred to a different behavioral health facility that can accommodate people that are wheelchair-bound. As SCFD and A.M.R. were facilitating the medical transport for ██████████, he became uncooperative with them, and they requested Police assistance. P.O. Shatto responded back to assist. As soon as P.O. Shatto arrived, ██████████ swung at P.O. Shatto, which she was able to deflect. P.O. Shatto placed ██████████ in a control hold and held him face down into the gurney until he was able to be secured by the paramedics for transport.

OFFICER STATEMENT:

P.O. Shatto came to me at the office and informed me of the situation. It should be noted that I came out to TELECARE earlier prior to being informed of this incident to assist in getting ██████████ admitted. I was not aware at the time that ██████████ spat on P.O. Shatto. During my conversation with P.O. Shatto, she informed me that ██████████ spat on her, which struck her right forearm area. P.O. Shatto was assessing ██████████ for a 5150 W&I hold and was helping him to get into a wheelchair for her to be able to move him to her patrol vehicle. P.O. Shatto also informed me that ██████████ swung at her the second time she came back to TELECARE to assist SCFD and A.M.R. in getting ██████████ into a gurney. During the incident at TELECARE, ██████████ swung at P.O. Shatto, which she was able to deflect. P.O. Shatto ended putting ██████████ in a control hold and held him in the gurney until he was ready for transport.

OFFICER INJURIES:

P.O. Shatto was not injured from this incident.

WITNESS STATEMENT:

K-9 Officer Kramer #149 spoke to an employee of TELECARE who witnessed the incident, where [REDACTED] attempted to hit P.O. Shatto. This employee was later identified as [REDACTED]. According to [REDACTED], he and PO Shatto were attempting to lift [REDACTED] onto the gurney. As they were lifting [REDACTED] into the gurney, [REDACTED] proceeded to take a swing at P.O. Shatto. [REDACTED] interpreted this action as trying to punch P.O. Shatto. [REDACTED] added that [REDACTED] would have hit P.O. Shatto if she had not moved out of the way. According to [REDACTED], P.O. Shatto had to move her head backward to avoid being hit. [REDACTED] was within inches away from hitting P.O. Shatto. After [REDACTED] swung at P.O. Shatto, she was able to get a hold of [REDACTED] arms and held it down. (Please refer to P.O. Kramer's supplemental report for additional details).

SUSPECT STATEMENT:

I was not able to speak with [REDACTED] regarding this incident. [REDACTED] was already accepted on a 72 hour 5150 W&I hold and was transported via A.M.R. to Watsonville Hospital, waiting to be transferred to a different psychiatric health facility. At 2155 hours, Watsonville Hospital called regarding an issue with the 5150 W&I form that P.O. Shatto completed for [REDACTED]. The form was missing [REDACTED] birth date, and the facility name that he would be admitted to should have been left blank. This required us to physically drop off a new corrected 5150 W&I form at Watsonville Hospital. Since I could not leave the City limits, I sent P.O. Wilkins to drop off the 5150 W&I hold and had him contact [REDACTED] to try and get a statement from him regarding this incident under Miranda Advisement. Unfortunately, [REDACTED] was uncooperative and would not acknowledge P.O. Wilkins (Please refer to P.O. Wilkin's supplemental report for additional details).

NARRATIVE

During the initial time that I was at TELECARE, I noted that [REDACTED] had a small abrasion on his right foot that had fresh blood on it. The small abrasion was caused when [REDACTED] was placed in the back of the patrol vehicle. As a result, [REDACTED] was not able to stand up or assist officers in the process of them lifting him up onto the patrol car. I suspect that [REDACTED] foot dragged on the ground, which was consistent with his abrasion.

SUSPECT TRANSPORT AND BOOKING:

[REDACTED] was already placed on a 5150 W&I hold and was accepted by TELECARE before I was made aware of this incident. [REDACTED] was transported to Watsonville Hospital via A.M.R., awaiting transfer to a different psychiatric facility that would be able to attend to his needs.

VIDEO EVIDENCE:

I watched P.O. Kramer's, P.O. George's, and P.O. Shatto's body-worn camera, which they later downloaded into evidence.com. The video footages were consisted of what P.O. Shatto had informed me happened. I noted that on the video footage, P.O. Shatto was assisting [REDACTED] to get into the wheelchair at the Armory so that she would be able to place him in her patrol vehicle. [REDACTED] was upset, verbally aggressive, and demeaning to officers at the scene, specifically to P.O. Shatto. As P.O. Shatto placed [REDACTED] in the wheelchair, he turned and faced towards P.O. Shatto, spat on her right forearm, and told her, "fuck you."

PHOTOGRAPHS:

I took photographs of P.O. Shatto at the station. In addition, [REDACTED] present condition was captured via officers' body-worn cameras at the scene, including mine when I

While at the Hospital, I also provided Watsonville Hospital staff with a new 5150 form with the corrections made by PO SHATTO. The staff accepted the new hold and I cleared the hospital.
