**SUBJECT:** 2023 Pavement Rehabilitation Project – Riverside Ave. and San Lorenzo

Blvd. Striping Concept Plans (c400809) (PW)

**RECOMMENDATION:** Motion that the Transportation and Public Works Commission review, provide comments, and approve the Riverside Ave. and San Lorenzo Blvd. Striping Concept Plans for the 2023 Pavement Rehabilitation Project.

**BACKGROUND:** San Lorenzo Blvd. and Riverside Ave. are heavily traveled minor arterial streets which serve as main corridors and critical links between downtown, the east side of Santa Cruz, and the Main Beach area. During summer season, heavy visitor traffic utilizes segments of both streets as the primary access into and out of the beach area, accessing Highway 17 via Ocean St. These streets also provide bike and pedestrian connections to the upcoming Rail Trail Segment 8 improvements along Beach St, and the San Lorenzo River levee path.

The 2023 Paving Rehabilitation Project will resurface San Lorenzo Blvd. and Riverside Ave, as well as install new ADA compliant curb ramps at all intersections within the project area. The paving project provides an efficient opportunity to make improvements to bicycle and pedestrian facilities in these corridors.

**DISCUSSION:** Staff has developed a concept plan which proposes to improve bicycle and pedestrian facilities by narrowing the existing traffic lanes in many locations, creating the required width to install sections of buffered bike lane on San Lorenzo Blvd. between Laurel St. and Riverside Ave, and a buffer for eastbound bicycles through the busy intersection at San Lorenzo Blvd and Ocean St. The plan includes the addition of new crosswalks at side streets which currently have none, green pavement markings at bicycle conflict zones, and new bike boxes at several intersections. The plans also include improved markings at access points to the San Lorenzo River levee path which parallels San Lorenzo Blvd, and the upcoming Rail Trail Segment 8 improvements. The concept plans are included here as Attachment 1.

The striping improvements were designed based on the California Manual on Uniform Traffic Control Devices and the National Association of City Transportation Officials Urban Street Design Guide.

This project is in alignment with and will assist in implementing components of the General Plan and Climate Action Plan. The General Plan calls for a "citywide interconnected system of safe, inviting, and accessible pedestrian ways and bikeways" (Goal M4). The Climate Action Plan

includes the transportation objective to meet an 80% reduction in greenhouse gas (GHG) emissions by 2050 which will be accomplished largely by providing low-carbon transportation options that rival the efficiency and safety of the automobile.


**FISCAL IMPACT:** The project is funded in the FY24 Capital Improvement Program (c400809) budget. There is no impact to the General Fund.







2023 PAVING PROJECT SAN LORENZO BLVD.
