*P3a. Description: (Describe resource and its major elements, include design, material, condition, alterations, size, setting, and boundaries) This two-story Victorian-era Queen Anne residence is an imposing composition of interlocking details. While having unique details, it also exhibits many of the common traits of the height of the Victorian era in Santa Cruz, including asymmetry of form and ornate detailing. The complex hipped and gabled form, with its projecting two-story bay window, cantilevered second story wing, and recessed entry porch are clearly architect-designed. The house included an open first floor porch according to a 1905 Sanborn Fire Insurance Map. By 1928, this open first floor was enclosed. Extraordinary details include the fluted pilasters at the bay window, turned spindlework at the porch beam, the flared form and trim of the shingled belly band, proportionately unusual Ionic porch columns, cruck braces at the front gable, and elaborate use of bulls' eyes and other Victorian gingerbread woodwork.

This house was constructed around 1893. The original owner(s) and architect are not known at this time. The earliest identified occupants are John T. and Laura Hawkins, who relocated to Santa Cruz from Oakland by 1910. The Hawkins operated a boarding house out of the residence. By 1918, Reverend M. L. Lanbourn is listed as the primary occupant in city directories.

By the 1930s, the property was owned by William E. Coats, who operated the El Rio Auto Park at North Pacific Avenue at River Street. Coats was from Mendocino County, and he purchased 14 acres along the San Lorenzo River, where he established El Rio Auto Park. The auto park offered cottages and tents for rent, individual gas kitchens, modern plumbing, playgrounds, boating and swimming. Currently, the El Rio Auto Park is known as the El Rio Mobile Home Park.



In 1935, Stella McIntyre was the owner-of-record. She worked as a secretary for a local attorney, C. B. Younger, and lived on the property until the late 1960s. From 1987 until 2006, the house was the residence of Hulda Hoover McLean, who was Santa Cruz County's first female Supervisor. McLean is also the niece of former U. S. President Herbert Hoover, and had family ties to historic Waddell Creek Ranch, a large ranch holding of the Hoover/McLean family and now Rancho del Oso Nature and History Center, located within Santa Cruz's Big Basin Redwood State Park.

SIGNIFICANCE

The property was found eligible for the California Register of Historical Resources under Criterion (3). The building is not individually significant to the development of the upper Downtown neighborhoods, and thus would not appear to be eligible under Criterion (1). The earliest persons associated with the building are not known and subsequent owners beginning with the Hawkins family are not known for significant contributions to the community. Hulda Hoover McLean is significant, being the first female County Supervisor, but her association with the property is contemporary, and her overall contributions to the local community did not occur in historic times. The property is not presently eligible for the California Register under Criterion (2). The specific architect of the building has also not yet been identified. The building however is architect designed, and appears to be eligible for listing under Criterion (3), as the building is a distinctive representative of its time as a late nineteenth century Queen Anne design.

When considered for listing within the Historic Building Survey of the City of Santa Cruz, the property meets the following criteria:

- 1. The property is a significant example of the built environment heritage of the City as a representative of late nineteenth century residential architecture associated with the early development of the community; and
- 5. The building possesses special aesthetic merit and value due to its quality of architecture, retaining sufficient features that show its architectural significance; and
- 6. The building possesses distinctive stylistic characteristics of the Queen Anne style; and
- 7. The building retains sufficient integrity to accurately convey its significance.

<u>Integrity</u>

The property maintains most of its apparent historical integrity as per the National Register's seven aspects of integrity. It maintains its original location on Walnut Street in the downtown area of Santa Cruz. The property is still surrounded by most of its apparent historic setting, including surrounding houses of similar age, scale and design and parcels with similar setbacks, parking, and streetscape. The house retains its residential scale and feeling and continues, through its form, massing and detailing, to illustrate its associations with minor patterns of residential design and development in the last decade of the nineteenth century. The house retains its integrity with its Victorian-era Queen Anne design, including: its asymmetrical raised form, hipped main roof, turned spindlework at the porch beam, the flared form and trim of the shingled belly band, proportionately unusual Ionic porch columns, cruck braces at the front gable, and elaborate use of bulls' eyes and other Victorian gingerbread woodwork. Additions have occurred to the rear of the building in the twentieth century, but do not impair the visual integrity of the building from the public right-of-way.
